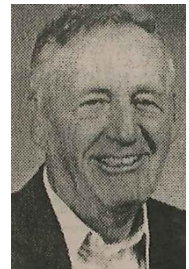

Death Comes Suddenly To Prominent Business Man – HOGUE EDELEN HEART VICTIM – Passes Away Few Minutes After He Is Stricken Early Sunday Morning – WAS LEBANON NATIVE

R. Hogue Edelen, member of the firm of John B. Carlile & Co. president of the Citizens National Bank and one of the city's most prominent business men, died suddenly at his home on West Main street Sunday morning at 4:15 o'clock. Death was due to heart trouble. Although not in good health for the past two years, he seemingly was as well as usual when he retired Saturday night. He awoke about 4 o'clock feeling ill and a physician was immediately summoned, but he lived for only a few minutes after the physician arrived. News of his passing came as a profound shock to every one and caused wide-spread sorrow throughout the community.



Mr. Edelen was for more than forty years with Carlile & Co., one of the largest and best known mercantile firms in central Kentucky. His first position with the store was as bookkeeper. Several years later he became interested in the firm as one of its owners, having with W.P. Myers and C.H. Litsey purchased a half interest from Col. John B. Carlile. Following the death of Col. Carlile the three surviving partners, together with W.W. Litsey, now deceased, took over the Carlile interest in the business. The store has since been conducted in the same firm name, and Mr. Edelen during all these years has looked after the office work and had general charge of the accounting department, a position for which he was particularly well qualified. He was regarded by every one as a safe, conservative business man, and much of the outstanding success of the firm has been due to his splendid business ability.

He was elected president of the Citizens National Bank on May 23, 1930, succeeding the late J.A. Kelly, and had since held that position. Previous to his elevation to the presidency of the institution he served for four years as its vice president and before that had for many years been a director. He was also a director of the old Home Telephone Co. and helped to organize that company, serving as its secretary until it was sold to the company that now owns it. Mr. Edelen was also prominent in fraternal circles, having been a member of Marion Commandery, Knights Templar, and also of the Lebanon Rotary Club. He was interested in every movement that had the betterment of the community for its object, and was one of the city's most public spirited citizens. He was one of the few citizens whose financial gifts made possible the present Marion County Library building on East Main street. He was a member of the Episcopal church, but as there is none in Lebanon he was a regular attendant at the Presbyterian church.

Mr. Edelen was a son of George T. and Amelia Edmonds Edelen, both deceased, and was born in this city on July 26, 1867. He was reared and educated in Lebanon and all of his life was spent here. He was married to

C.J. Edmonds, Banker Here for 68 Years, Expires - Seriously Ill Three Weeks

Heart Ailment Ends Career of Prominent Citizen Monday Afternoon – Interment Wednesday

Cleland Jackson Edmonds, 84, prominent in Lebanon banking circles for sixty-eight years and one of the county's most widely known citizens, died Monday afternoon about 1:45 o'clock at his home on West Walnut Street. His passing was not unexpected as he had been in a critical condition since suffering a heart attack while sitting in a chair in his living room on the night of February 12. Two nurses had been attending him.

Although virtually no hope had been held for his recovery, he had shown temporary improvement and had rallied from a coma into which he lapsed immediately following the attack. As recently as Sunday he was able to talk rationally with members of his family.

Resigned Bank Post in January.

Stricken ill about two years ago, he spent several months in a hospital but responded well to treatment and was later able to resume his duties as president of the Citizens National Bank, the institution with which he had been connected since he was 15 years old. In October, 1947, he was again stricken and in December was under the care of specialists at a Louisville infirmary for three weeks. Although he was improving at his residence prior to the fatal attack, he tendered his resignation as head of the bank at the January meeting of its directors. However, he had continued his membership on the board.

Elected Bank Head in 1932.

Mr. Edmonds began his banking career when, as a youth just out of school, he accepted a position as bookkeeper with the Citizens Bank, where he was assigned to do simple clerical work under the guidance of Henry Wilkin, who was then cashier, and Fletcher Wilson, the vice president. Since that day in July, 1879, he had filled virtually every office in the bank – assistant cashier, cashier, vice president and finally president. He was elected to the latter post following the death of R. Hogue Edelen, in 1932.

Besides his affiliation with banks and bankers, he held membership in many other civic, fraternal and church organizations. At the time of his death he was a member of Lebanon Lodge No. 87, Edmonds Chapter No. 83 and Marion Commandery No. 24, of the Masonic Order, and also the Kosair Temple of the Shriners in Louisville. He was a past president of the Lebanon Rotary Club and was long an elder in the United Presbyterian Church, serving as clerk of the Session for more than twenty-five years.

Active For Advanced Age.

Remarkably active despite his advanced age, he seldom missed a day at his office until his health began to fail in 1946. He often walked the mile distance between his home and his business and, in the summer season frequently insisted upon doing late afternoon chores around his dwelling – chores which would have been strenuous for the average man thirty years his junior.

His mind, like his body, was alert and until his last illness he retained an unusual interest in virtually all national and local affairs. When past 80, he often accompanied delegations to bankers conventions, Rotary Club meetings and church conferences, returning home from long motor trips apparently less tired than most of his companions.

Although denying that his memory was good, he could recall many major events bearing on the growth and development of Lebanon within the past sixty or sixty-five years. The introduction of gas lights and then electric service, the water works, the telephone system and the horseless carriage were all vivid in his recollection.

Born in Lebanon.

A son of the late Albert and Sarah Robertson Edmonds, Mr. Edmonds was born here December 23, 1863, and had spent his entire life in the community. He attended various private schools conducted by Dr. T.A. Bracken, John Bentley and a Mr. Harris before joining the staff of the Citizens Bank. Since 1872 he had occupied the present Edmonds home on West Walnut Street, living with his half-brother, A. Lewis Edmonds, and Mrs. Edmonds.

Mr. Edmonds' courteous manner and immaculate attire were matched by his Christian faith, his absolute integrity and his generosity to others. Although extremely modest about his gifts, he contributed to scores of charities regularly and was equally liberal with his donations to projects for the welfare of the community. He was one of eight local men whose financial aid made possible the present Marion County Free Public Library building.

His only survivor is his half-brother, A. Lewis Edmonds, with whom he made his home. A brother, J.E. Edmonds, who served as Mayor of Lebanon and was long identified with the shoe business here, died about fifteen years ago.

He was preceded in death by his parents, Milford Purdy and Mildred Louise Evans.

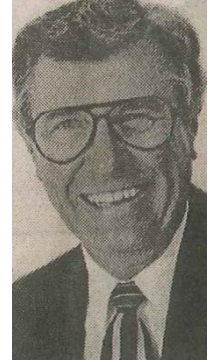

He was preceded in death by his parents, Joseph Al and Ida Belle Marple Evans.

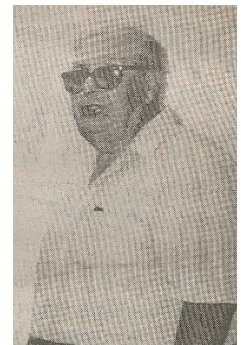

Campaigner for handicapped rights dies at 50

Jimmie Dale Evans, 50, who fought for handicapped rights in Kentucky, died March 16, 1996 at St. Joseph Hospital in Lexington. He lived at 425 Cloverdale Drive, Danville.

Evans in his wheelchair was a familiar figure in government halls. He was instrumental in making many public buildings throughout the state accessible to the handicapped. A federal complaint he initiated in 1977 against the University of Kentucky resulted in the whole campus becoming handicapped accessible.

Evans was paralyzed by injuries received in a 1968 automobile accident.

Evans never hesitated to ask local governments to correct problems areas he saw that affected handicapped people. While working for John Y. Brown Jr.'s gubernatorial campaign, Evans found out that many county courthouses were not accessible to people in wheelchairs.

After Brown's election, Evans filed 181 federal complaints to make every courthouse, city hall and post office accessible in Kentucky to the handicapped. Evans won in every case he filed.

As a result of his efforts and appearances at public meetings, many city halls, post offices, and county courthouses were accessible several years before the federal Americans with Disabilities Act was enacted.

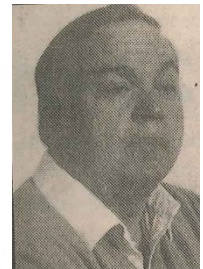
After completing rehabilitations following his accident, Evans for a time served as private investigator for the Department of Treasury.

In 1981, he helped draft Kentucky's Personal Care Attendant Program, which enabled a disabled individual to be able to live in the community without being institutionalized.

Born Dec. 17, 1945, in Marion County, Evans was a son of Edna Mae Lane Evans of Danville and the late Charles Evans Jr. He was a member of the West End Church of Christ. He attended early elementary school in Bradfordsville, middle school in Hustonville and attended Danville High School. He was a graduate of the University of Kentucky and attended UK's College of Law.

He was working for Mid-State Mortgage Co. when he became disabled. He had also been in the real estate investment business.

Additional survivors include a sister, Susie Kelly of Danville; and one brother, Kenneth Evans of Lawrenceburg.

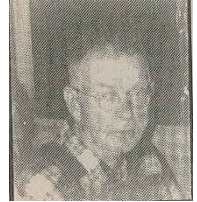
