# Marion County Native, Dies

(Editor's Note: The following Kingston poolroom on Market, near article concerning the death of Ed Alvey, king of Louisville gamblers, who or sinally made his home in Market, near third. Success was uninterrupted until all poolrooms were chased from the business district.

After the showdown came and Alvey had to close his Market Street marked by frequent skirmishes with

marked by frequent skirmishes with the law, clashes with other gaming interests, and once with kidnapers, ended when death won the last bet from Ed Alvey, 70. Louisville's "King of Gamblers," Friday night at St. Joseph's Infirmary Almost blind, he was moved January 16 to the hospital from his home, 1719 South Fourth, suffering from an abdominal disorder and diabetes.

Death "broke the book," a feat no bettor had been able to accomplish since a day in the late '80's when a green Marion County boy came in from the hills between Loretto and Holy Cross to start a poker game in the back room of a Lebanon saloon. Alvey there laid the foundation for a life of chances which, friends estimated, caused millions to flow through his various card and dice games and various card and dice games and

His personal wealth, never discussed by him, was at times variously estimated from "broke" to a million.

Alwey's judgment of men and affairs not only shielded him in his cambling operations, but sharpened a native political shrewdness. As Alvey bet, so went elections with surprising regularity.

His knowledge of schoolbooks was limited, and he wasn't a hand at figuring with pencil and paper, but the

room near Churchill Downs, outside Louisville. The place ran without much interference until in 1907 young Sheriff A. Scott Bullitt raided "Ponyville," the section around the track. The raids were a blow, but not a fatal one to handbooks. They scattered over the city in cigar stores, saleons and restaurants.

In December, 1933, Detective Chief E. A. Larkin led a raid on what he termed the "biggest handbook headquarters in Louisville" in the Tyler Building. It was Alvey's, By that time Alvey was taking bets from all parts of the United States and some from foreign countries. Detectives got his books and from them learned he had an income in 1922 of more than \$63,000. The next year Alvey's headquarters in the Louisville Hotel were raided, resulting in five arrests and \$5.00 fines all 'round.

#### \$50,000 Ransom Talked

The kidnaping racket, which G-men ruined in recent years, was beginning in 1928 when first victims were gam lers and operators in the "big easy money." In December of that yes Alvey was reported kidnaped from his home and held for \$50,000 ransom. Two days later he walked into the house saying he had paid no ransom, but that he didn't know where he had been because his abductors had sealed his eyes with tape. funerals were not preached by the burial they were often preached some weeks, or perhaps months afterwards. This was especially common among the colored people and, as I remember it, the day was and shot Wilkerson often made an occasion for a general good time.

> So far as my observation goes this has all passed away in this section, even among the colored people.

In those days, as I remember low, there were no flowers for the coffin or the grave of the departed to delight the sensibilities of the optic nerve or to stimulate the pleasures of the olfactory nerve-one could not see their loveliness and beauty and the other could not inhale their fragrance, and in a few hours these flowers would wilt and fade away. But now, while nature has not changed so far as the dead or the flowers are concerned, we see leads of beautiful and expensive flowersand this tendency has grown till it has become embarrassing to the feeling or finances, and sometimes to both, to the friends of the departed. I wonder if this, like the delayed funeral, will pass away and that future generations will look back on this custom as a foolish fad.

The present Kentucky Bar Association dates back to 1900 when a group of Louisville and northern Kentucky lawyers combined efforts to create a unified statewide organization. Among the bodies created at the first meeting of the new Kentucky State Bar Association was a Committee on Necrology, which was charged with honoring the members who had died during the year with biographical tributes. From the beginning of the annual publication of the bar association's Proceedings in 1902 until 1942, these brief biographies recorded the lives on both the famous and obscure, creating a rich resource of information about the Kentucky lawyers at the turn and the early part of the  $20^{th}$  century.



#### Jesse Alvey and his descendants

Though he lived his entire life in Maryland, almost all of Jesse Alvey's children left St. Mary's County, Md., for Kentucky. Alvey's descendants settled first in the portion of Washington County, Ky., that later became Marion County. Though a few found their way elsewhere, Jesse's descendants generally moved on to Hardin County (where many descendants live today) or to Ohio, McLean, or Daviess counties. One other destination was Jefferson County and the city of Louisville, where many rural Alveys moved in the 1880-1920 period when industrialization brought millions to the economic opportunities of American cities

Jesse Alvey (b. about 1730, St. Mary's County, Md., d. 1803, St. Mary's County, Md.) was a son of John Alvey and Mary Clarke and a greatgrandson of Joseph Alvey, who immigrated from Knotting, Bedfordshire, England, to America in 1657.1

Jesse Alvey died between 10 January 1803, when he signed his will, and 7 February, when the will was presented in court by his executor. His bequests, in order, were: Grandson James Alvey, "one horse colt called Prince"; grandson Charles Alvey, "one colt called Fox"; "my daughter" Elizabeth Alvey, "one mare and colt her single life"; "my daughter"

Elizabeth Alvey, "the best feather bed and furniture forever"; "also to my daughter Elizabeth Alvey the next best bed her single life"; "My other three children," ("Benedict Alvey, Ann Alvey and Catherine") one shilling sterling"; and granddaughter Mary Alvey, one cow and calf. The remainder was to be equally divided between "my son John and my daughter Elizabeth Alvey." Elizabeth Alvey was appointed executor. Witnesses were George Booth, John Branson, and Zephaniah Gardiner.

Jesse Alvey lived during a period of much

change in lifestyle and religion. The religious freedom that many Catholic immigrants had sought and found in Maryland had all but evaporated by the time of the Revolutionary War. In fact, Catholics were required to hide their





The name Alvey is included in lists of the earliest Catholic settlers, and Jesse's cousins John and Robert Alvey appear on the 1785 list of Nelson County tithables. His cousin Thomas Green Alvey appears for the first time in 1787, the year Thomas Hill and Philip Miles led the league's third group to the frontier.2

Bennett/Benedict Alvey was the first of Jesse Alvey's children to head for Kentucky. He brought his wife Mary and their children Henry and Susannah to Washington County by 1799.3

Mary Ann Brawney, on 15 April 1816 in Hardin County, Ky.<sup>9</sup>

Though he appeared on the 1816 and 1820 Washington County tax lists (with one horse or mare), Henry had moved to the Rineyville area of Hardin County by about 1812. He was one of the first members of St. John the Baptist Church there.<sup>10</sup>

Mildred "Minnie" Elizabeth Poole),<sup>44</sup> and Daniel Albert (b. 1878, Daviess County, d. after 1907, m. Cora James).

Frances died sometime between the 1900 and 1910 census, but I am not sure where or where she is buried. When Jerome died on 15 March 1920 in Daviess County, his obituary in the Owensboro Messenger stated that he was survived by 14 children and 84 grandchildren. I only know of 13 of the 14 children. The obituary is somewhat in question, and it also states he was born in Marion County, which did not exist in 1827 but was very close to Hardin County. I often wonder if I have Jerome with the wrong parents even though all evidence points in that direction. Almost all the Alveys that settled in Daviess County were Catholics, but by the time Jerome died he was buried in the Mt. Zion Methodist Cemetery in Owensboro. Some of the couple's children are buried in Mt. Zion, while many others are in St. Joseph Catholic Cemetery in Evansville or Mater Dolorosa Catholic Cemetery in Owensboro.

consented to her son Benedict's marriage on 6 January 1847.

It is believed that James and Susannah are buried on their farm, but no tombstone or death record has been found. Since they lived in the vicinity of St. Clare Catholic Church and cemetery, it's possible they might be there, but with no legible tombstone.

After James died in 1845, his family moved closer to Elizabethtown and Rineyville. Many family members are buried in either St. John the Baptist Catholic Cemetery in the St. John community of Hardin County or St. James Catholic Cemetery in Elizabethtown. All were farmers for most of their lives. Around the turn of the 20<sup>th</sup> century, descendants began migrating north to Louisville and for Michigan, Colorado, and California to follow new job markets opening up in those states.







# The Alvey Family of England, Maryland, and Kentucky

By Robert Lee Alvey Sr.

Part Four

John Henry "Old John" Alvey Sr. and his descendants

Parts One through Three of this series brought the Alvey family forward in time from Generation One; Arthur Alvey in England of about 1550 through the son of Jesse Alvey, Benedict Alvey and his two children, Henry and Susannah. Part Three included the known information on Susannah's descendants after her marriage to her first cousin James Alvey, also a grandchild of Jesse Alvey. The Alvey family saga now continues with a third son of Jesse Alvey, John Henry Alvey Sr., often labeled "Old John" Alvey Sr. This John Alvey was most likely Jesse's oldest son, already established with a wife and daughter in the 1790 St Mary's County, Md., census. John Henry Sr., along with the family of his deceased brother James Alvey, came to Washington County, Ky., sometime around 1806-1807, a few years after his father's death in St Mary's County in 1803. Both John and his sister-in-law Elizabeth "Betsy" Alvey were shown on the 1807 tax lists of Washington County and were included in that county's 1810 census. Some years later, in 1834, the portion of Washington County where the Alveys settled became part of what is know today as Raywick, Loretto and Chicago (now St Francis) in Marion County. While this branch of the Alvey family moved around substantially in later years, there are still many descendants of John Henry in Marion County. A devout Catholic family when they arrived from Maryland in 1806, the vast majority of this family remains with the Catholic faith today. The church registers and cemeteries of St Francis Assisi in St. Francis, Ky., St. Francis Xavier in Raywick, Ky., Holy Name of Mary in Calvary, Ky., St. Augustine in Lebanon, Ky., St. Charles in St. Mary's, Ky., all of Marion County and St. Rose in Springfield of Washington County have long lists of the Alvey family descendants. The John Henry Alvey family started as did most families of this area, especially the Catholic families that migrated from Maryland, as farmers. As times changed, the family adjusted and many became blacksmiths, carpenters, tavern owners, and even county employees such as jailers and county office workers. Besides populating the local countryside, this family has members from California to Maine who still visit their cousins in Loretto, Lebanon, and Raywick. Many reside in Louisville, Evansville, and Indianapolis, but still call Marion County, Ky., their home. 2






# Library & Special Collections

Thousands of researchers blaze their own trail through the historic landscape each year with the assistance of the Society's research facilities. Here genealogists can trace an ancestor's path aided by family histories, census, church, and cemetery records, family Bibles, and land ownership and military service records.

In addition, the Society's Special Collections house hundreds of thousands of manuscripts, photographs, maps, rare books, oral histories, pioneer accounts, diaries, albums, personal recollections, and more—all helping researchers come face-to-face with Kentucky's distinctive heritage.

# Publications

The Society publishes books and periodicals that meet the needs of genealogists, historians, and scholars alike. The publications program produces two quarterlies: *The Register*, a journal of scholarly research in Kentucky history, and *Kentucky Ancestors*, a genealogical magazine providing statewide coverage for family history researchers. The Society also publishes *The Chronicle*, a membership newsletter offering information on Society events, exhibits, and programs.



The Library and Special Collections facilities contain the stories of Kentuckians and their families, from the 1700s to the present. Researchers have access to hundreds of thousands of books, records, and photographs.

# Education

Every year thousands of people travel to Frankfort from all across America for hands-on tours, interactive exhibits, touch carts, historic character reenactments, family workshops, theatrical presentations, symposia, and festivals that celebrate Kentucky's history. In addition, the education program offers Kentucky history curriculum materials to teachers for use in their classrooms. The Society's outreach programs help people from Ashland to Paducah discover Kentucky's unique past. These programs include the Kentucky Junior Historical Society, Museums To Go, and Historical Highway Markers. Grant and technical assistance activities sponsored by the Folklife, Local History, and Oral History programs give citizens the tools to document and present their own history.



# The Alvey Family of England, Maryland and Kentucky

Henry Alvey Sr. and his descendants (continued from Part Two)

Part Two of this series focused on the descendants of Henry Alvey Sr. Because this family was so large, Part Two ended at Generation Nine. I would now like to continue to Generation 10 and some selected portions of his family for the next generation. Henry Alvey Sr. was a grandson of Jesse Alvey of St. Mary's County, Md. He came to Kentucky with his parents Bennett/Benedict and Mary Alvey and his sister Susannah about 1798. The family lived in Washington County, Ky., for a number of years before eventually moving to Hardin County, where Henry and Susannah lived with their respective families until the late 1840s. At that time, Henry sold his property in Hardin County and moved with his third wife and younger children to Daviess County. During the next several years, all but one of Henry Sr.'s adult children followed him to Daviess County. Nearly all the Alvey descendants living in Daviess, McLean, and Ohio counties of Kentucky today descend from Henry Alvey Sr. and one of his three wives, Rachel Summers, Anastasia Metcalf and Catherine "Kitty" Lanham. Many of the pictures included within this article were provided by Mrs. Nancy Louise Alvey Witmeyer of Los Angeles and Mrs. Melva Koerner Petway of Benton. We begin with Generation 10, please refer to Kentucky Ancestors, Volume 38, Number 3 for details leading up to the information included herein. 





# Museums


The Kentucky Historical Society operates three unique sites in downtown Frankfort that tell the story of our state's history. At the Frankfort facilities and through the Society's outreach programs, the Kentucky story stirs the hearts of over a quarter-million people every year.





The Kentucky Military History Museum (left) houses a collection of artifacts from the state's martial past. It was built in 1850 as the state arsenal. Union and Confederate troops fought to control it during the Civil War. The Old State Capitol, (right) completed about 1830, is a gem of Greek Revival architecture. Designed by Gideon Shryock, it was the first state capitol of its type west of the Appalachian Mountains. It is today operated as a museum and is open for tours.

# KENTUCKY HISTORICAL SOCIETY



Kentucky History Center—Home to the Society, this building contains the state history museum, changing exhibit gallery, research library, gift shop, rental facility, and the Society's educational and publications programs.

Old State Capitol—Completed in 1830, this site is a national historic landmark. Its House and Senate chambers, graced by Kentucky paintings and sculpture, tell the story of state government in the commonwealth.

Kentucky Military History Museum—Two centuries of Kentucky's military heritage are traced through an extraordinary collection of weapons, uniforms, flags, and photographs. Housed in the 1850 Old State Arsenal, the museum operates in conjunction with the Kentucky Department of Military Affairs.

# BOOK NOTES

### Books on Kentucky genealogy and history contributed to the KHS library by authors, publishers, and compilers

Pendleton County, Kentucky: Court of Quarter Sessions Minutes, 6 August 1799 to May 1808. Transcribed by Janet K. Pease. (2004. Pp. 461. Indexed. Softcover, \$25, plus \$3.50 shipping and handling. Kentucky residents should add \$1.50 in state sales tax. Order from the Grant County Historical Society, 12 Charlotte Heights, Williamstown, KY 41097.)

This work is a transcription of the original found in the Pendleton County Clerk's Office. The everyname index lists surnames of about 900 people, including many whose descendants live in Grant and Pendleton counties. Also included are definitions of legal terms to help explain early cases involving slander, trespass, unpaid debts, estate settlement disagreements and murder. Surnames include Ackels, Arnold, Barnes/Barns, BennettColvin, Coppage/Copage, Doty, Downard, Earls, Ellis, Flournoy, Fewell/Fuell, Goodwin, Groshon, Hawkins, Hinkston, Indicut, Inlow, January, Jouet/Jouitt, Kennett/Kinnitt, Lanier, Lightfoot, McLaughlin, Mountjoy, Nichols, Norton, Ockeltree, Oens, Pickett/Picket, Quick, and Rice.

This work consists of abstracts of Prerogative Court of Maryland records for the period 1658 to 1674. The Prerogative Court was the focal point for probate for colonial Maryland. A judge and various clerks staffed the court. All matters of probate went directly to the Prerogative Court, which was located in the colonial capital. Eventually administration of probate was delegated to the several county courts; however, many documents related to probate continued to be filed at the Prerogative Court and not in the corresponding county. Skinner combed through administration bond, will, inventory, administration

account, and final balance entries to produce this collection. The abstracts are arranged in chronological order by court session, and in every instance they give the names of the principals (testators, heirs, witnesses, administrators, and so forth). In many cases we also learn the details of bequests, names of slaves, appraisers, and more. In all, Mr. Skinner identifies some 6,000 17th-century Marylanders whose existence and activities would otherwise remain hidden in some rich but very obscure records.

# The Alvey Family of England, Maryland and Kentucky

Henry Alvey Sr. and his descendants (continued from Part Two)

Part Two of this series focused on the descendants of Henry Alvey Sr. Because this family was so large, Part Two ended at Generation Nine. I would now like to continue to Generation 10 and some selected portions of his family for the next generation. Henry Alvey Sr. was a grandson of Jesse Alvey of St. Mary's County, Md. He came to Kentucky with his parents Bennett/Benedict and Mary Alvey and his sister Susannah about 1798. The family lived in Washington County, Ky., for a number of years before eventually moving to Hardin County, where Henry and Susannah lived with their respective families until the late 1840s. At that time, Henry sold his property in Hardin County and moved with his third wife and younger children to Daviess County. During the next several years, all but one of Henry Sr.'s adult children followed him to Daviess County. Nearly all the Alvey descendants living in Daviess, McLean, and Ohio counties of Kentucky today descend from Henry Alvey Sr. and one of his three wives, Rachel Summers, Anastasia Metcalf and Catherine "Kitty" Lanham. Many of the pictures included within this article were provided by Mrs. Nancy Louise Alvey Witmeyer of Los Angeles and Mrs. Melva Koerner Petway of Benton. We begin with Generation 10, please refer to Kentucky Ancestors, Volume 38, Number 3 for details leading up to the information included herein. 


