Three I direct that all of my live stock, household and kitchen furniture farming utensils be sold by my executors on a twelve

months credit etc.

Four I direct the proceeds of the sale of all of my things be divided between all of my legal heirs that is to say the children, the heirs of my deceased daughter Elizabeth Hardin once wife of Benone Hardin who may be living at he time of my death one fifth part. The children and heirs of my deceased son William Askren who may be living at he time of my death one fifth part. My daughter Mary Askren wife of Josiah Askren if she should survive me at the time of my death if not her children one fifth part. Thechildren of my deceased daughter Hartha Curmins that may be living at the time of my death one fifth part. And the children of my deceased daughter Sarah Gillihan that may be living at the time of my death one fifth part.

Now I add this condition to the above distribution I gave to my children as they married and left me property to the following amount: Viz: To Ilizabeth Hardin one hundred and three dollars, to William Askren ninety siven dollars, To mary Askren eighty eight dollars, To Hartha Cumins seventy eight dollars, To Sarah Gillihan ninety three dollars and I also hold on Mathes Cumins two notes for cash advance furing the life time of his rife Bartha one for forty dollars dated July 13, 1819 and one dated October 20, 1828 and one note on Mark Gillihan for thirteen dollars dated August 7, 1830. The above notes to be deducted from my children's parts. And my daughter Hary Askren in the proposion received by her etc.

I hereby appoint my son in law Josiah Askren executor to this

my last will, etc.
