Thank you for the books. I have added them to our collection. Our patrons will enjoy them.

The newspaper article was great! I enjoyed reading it. I added it to our information file on Ham Days. You were so thoughtful to send it. I really appreciate all the nice things you have done for us.

I found the following baptisms in St. Matthews Church records:

WILLIAM P. BEECHAM (convert) born 19 December 1806 to Jereboam Beecham & Mary Downum. Baptized 24 May 1885.

JOHN HILMAN BEAUCHAM born 24 March 1882 to Thomas Beauchum & Martha Buckman. Baptized 11 Mar 1883. Sponsor was Mary Atkins.

No other baptisms for any Beauchamp (Beecham, Beaucham) in St. Matthews or Our Lady of the Hills records.

No death records other than the two (William & Ben) you have. I checked both St. Matthews and Our Lady of the Hills.

I found the following in book: **Early--1872 Marion County Kentucky Marriages Book 1** compiled by Dianna Bertram. :

Miles, William, 20 yrs., resident of Marion Co., KY ; Farmer ; born Marion Co. ; father born Marion Co. ; mother born Marion Co.
and

Beauchamp, Mary Jane, 19 yrs., resident of Marion Co., KY ; born Marion Co. ; father born Marion Co. ; mother born Marion Co. To be married at fathers residence on January 8, 1867.

Ministers return indicates that marriage was held at St. Charles Church with J.B. Hutchins officiating. Grooms name listed as Wm. N. Miles. Witnesses: Thomas Miles and Wm. Beauchamp.

Our Marion County marriage records are limited. There are no records between 1834 and 1863 (those were destroyed by fire during the Civil War.) To date only one book has been done on Marion County Marriages: ***"Early--1872 Marion County Kentucky Marriages Book 1"*** by Dianna Bertram. I heard Dianna may have finished a second book on Marion County Marriages but have no documentation on it as of now.

No 1890 census for Kentucky (nor many of the other states) exist. Only fragments for some states. There are no fragments for Marion County, apparently no records survived. Sorry.



Dear Mary: Enjoyed our little chat. this week. I mentioned Martha S Buckman d/o William and Malinda Shircliff Buckman born 1853 and married 26 Feb 1878 at St Matthews to Thomas Marion Beauchamp. No record of her death but Thomas remarried about 1893 and again later to Josey Corbet who survived him, We find no record of Thomqas's mother Elizza Ford Beauchamp wife of William dying but she ws not in the 1880 census. William as you gave me the cemetery records was buried at St Matthews in a double grave with his son, Ben who died about 1902. So if you run across anything about the Fords or the Beauchamp women's death you know who wants to hear from you. Too many of the names that were in the late 1900 or 1900 census's just disappear. And as I told you Thomas obit in 1926 lists a brother, never heard of before and was not in the Louisville census or city directories or the Ky 1911-93 death records.

Now you know why we genealogists look a little daffy and maybe cross eye. Have a nice Christmas and maybe young volunteer will have time to look for any Beauchamop names in the 1890 csnus if you have one.

Dear Mary:

I am back again to ask about a Beauchamp or two if your or one of your staff has a minute or two to spare.

I noticed in one of the early letters you sent me that you had marriage records of St. Matthews Church. The church would not answer my letter. I would like to know if the records would cover the period to show if there is a marriage of William Beauchamp and a Mary E Ford which would be in the late 1840s and of Thomas Beauchamp and Martha Buckman which would have been before 1880 for they are in the 1889 census with a one year old child.

Strangely there are five wives of three generations of Beauchamps I cannot find a record of their demise but if this data is available I will just about wind up my Beauchamps in Marion County and you will get a copy. The big problem now seems to be that Thomas's obit in 19326 shows a brother, Malachy in Louisville and the city directory there does not show him from 1922 to 19289n and the earlier set of death records between 1926 and 1938 does not have him dying. He also is not in any of the censuses between 1850 and 1920 that I have seen or have a record.

So if you have time to take a reading I will appreciate hearing from you.

ington County. She attended grade school at St. Agnes (Washington County) and later graduated from Nazareth in Nelson County and attended Spencerian Business College in Louisville. She was the daughter of Richard Oliver (Ollie) Barber and Roxy Lee Wakefield of Maud, KY. Ollie was a well-known farmer. Their home was located five miles from Springfield on the Bardstown Road. The house was built by Thomas Hamilton and in later years was owned by Ollie's son, Tink. Lydia was the third child born to Ollie and Roxie. The other children were: John Franklin (deceased), who owned and operated the farm in the Maud community that had belonged to the Wakefield family. He was married to Roberta McIntyre and had seven children - Oliver Houston (Tink) Barber, Springfield, was co-owner of Barber Hardware, married Alethaire Kelly six children. Roxy Belle Hubbard - married D.C. Hubbard, two children. Richard Wakefield (Buddy) Barber, Quincy, IL, married Eleanor (Nodie) Smith - three children.

Ollie was the son of John R. Barber and Mary Florence Anderson Ollie had two brothers Alex and Lyman, and two sisters, Mrs. H. J. (Marie) Boone and Mrs. C.D. (Louise) Robertson. There were four sons from John R's first marriage to Piety Yancy; namely Kent, Yancey, P.S. and John Lilly.

Roxy Lee Wakefield was the daughter of James Franklin Wakefield and Lydia Catherine Bishop - one sister, Elizabeth, one brother, James Houston Wakefield, all of Maud, KY.

The Bob RoBards children are now married and have moved with their families to other locations.

Bobbie Lee married Charles Mathews with the FBI and resides in Portland, OR after having lived in Milwaukee, Baltimore and Atlanta. They have three children - Katie, 18, Charlie, 16, and Sally, 12.

Richard married the former Linda Minogue, Bethesda, MD. He served two years in the U.S. Army and returned to Kentucky to finish his schooling at the University of Kentucky. He is presently editor and general manager of the *Central Kentucky News-Journal*, Campbellsville, KY.

They have three children - Margaret, 19, John Robert, 12, and Teri, 11.

John married the former Barbara Jean (Jeannie) Brown, Springfield, KY. They now reside in Louisville where he is a supervisor at Phillip Morris. They have three children - Lee Anne, 12, Ryan, 10, and William, 6.

WILLIAM GARRET BARR, was born in Daviess County, KY, Feb. 23, 1898 and spent most of his childhood in Browns Valley, KY. He was the son of George Roland Barr (1866-1934) and Ellen Mack Knott (1876-1960), who were descendants of Charles Hayden and Eleanor Elliott of Washington Co., KY.

William Garret married Sept. 28, 1920 Ruth Cecilia Payne (Oct. 20, 1901 - Aug. 2, 1982), daughter of George Douglas Payne (1858-1944) and Mary Magdalene Clark (1872-1933) who were descendants of George Hayden and Mary Elliott of Washington Co., KY.

Charles Hayden and George Hayden are brothers and sons of William Hayden m. (1) Elizabeth Thompson, who with his younger brother Basil Hayden, Sr., led the first group of Catholics from St. Mary's Co., MD to Nelson Co., VA (now Kentucky) in 1785. Charles Hayden m. Eleanor Elliott; Charles Hayden m. Eleanor 'Ellen' Hagan; Martha Hayden m. George Barr; George Roland Barr m. Ellen Mack Knott; George Hayden m. (1) Mary Elliott; George S. Hayden m. (1) Delphina Elder; Mary Valeria Hayden m. John A. Payne; George Douglas Payne m. Mary Magdalene Clark; William Garret Barr m. Ruth Cecilia Payne.

William Garret and Ruth were the parents of 15 children: Mildred, Louis, Helen, Billy, Herman, Mary Lillian, George Edward 'Jacky', Ruth Ann, Wilma, Jimmy, Janet, Martin, Angela, Gerald and Freddy and had 68 grandchildren.

The Barr Family lived in Livermore, McLean Co.,

KY until 1943 when they sold their home and moved to the farm in Daviess Co., KY near Panther Creek. When William Garret retired in 1960 they again sold their home and built a new home in Whitesville, KY where they lived until they died. He died Feb. 17, 1971. Both he and his wife are buried at St. Anthony Cemetery, Browns Valley, KY along with their parents.

BEAUCHAMPS, one of the early Washington County families that contributed considerably to the growth of that part of the county which is now Marion County and around Raywick was the Beauchamps.

Costin Beauchamp was born Dec. 17, 1738, to Robert and Ester Costin Beauchamp in Somerset Co., MD. Costin was the great-grandson of the family gateway immigrant ancestor, Edmund Beauchamp, who migrated from England to the Maryland Colony about 1665. He was the first clerk of the court of the Maryland Eastern Shore and then of Somerset County, a position he held from 1666 until about 1690. The Beauchamps accompanied William the Conqueror from Normandy in France to England in 1066 and Hugo de Beauchamp was one of the largest collectors of baronies for his support of William.

Costin moved to Kentucky from Delaware in 1791 and first appeared on the Washington tax rolls in 1796. His first son, Newell, settled near Chaplin and owned property in Washington County. He was the progenitor of most of the Beauchamps in Nelson County. Another son, Joshua, was a large land owner in Nelson County.

Sons Jereboam, Stephen, Thomas, and Robinson Pemberton who were born to Costin's second wife, Charity Robinson, settled in Washington County. Until Marion County was formed in 1834, there were about 25 deed transactions with Beauchamp involvement in Washington County.

Costin Beauchamp married a Mrs. Nancy Graham in 1808, his third wife. He died in Daviess County in 1818. There are no records of the deaths of his first two wives. A son of the third marriage was in the 1850 census in Hancock Co., KY.

The most active of the Beauchamps in Washington and Marion Counties early history was Jereboam, the farmer, trader, legislator, military officer, magistrate and sheriff. This Jereboam was not the Jereboam who was hung for his part as the principal in the Beauchamp-Sharp Tragedy. That Jereboam was Jereboam Orville, son of our Jereboam's brother, Thomas. Jereboam was born in Delaware about 1766 and married Mary Downham, daughter of Richard Downham, April 2, 1789 in Kent Co., Delaware.

Orval Baylor in his Washington County Historical Series, Article No. 56, published in 1904, listed Jereboam as one of the early settlers on Hardin's Creek; "These men built their homes in the wilderness of that district of Kentucky when the territory was in the confines of Nelson County." Jereboam's home place was first known as Benton's Lick Log about two miles from the mouth of the South Fork of Hardin's Creek and four or five miles from the Indian and Cedar Licks.

Actually, Jereboam left Delaware in 1794 and paid his first taxes to Washington County in 1795. W. T. Knott in his "History of Marion County" made reference to "The Thorpes and Youngs and Harrisons and Hughes and Clelands and Carters and Beauchamps and others (all long passed away) for their part in the development of western Marion County." Jereboam stands out as the most active Beauchamp.

Jereboam served Washington County as a representative to the Kentucky General Assembly in 1801 thru 1803, 1805, 1814 and 1815. He also served in the state senate 1809-13 and 1821-25. In 1809, the loser to

Jereboam in the senate race, Phileoman Waters, challenged his victory for "using spirituous liquors to buy votes", but the challenge was turned down by the State Senate and Jereboam served with distinction. In 1825, there was a strong political battle in the state over the issue of old and new state supreme courts. Jereboam took the side of the new courts and lost very badly. Jereboam had introduced the bill to the senate to remove the old courts. His next public service was as one of the members of the first fiscal court in Marion County in 1834. In 1836, he was appointed Sheriff of Marion County. This closed out his public career.

In 1811 when the winds of the War of 1812 began to blow, state militia units were formed. Jereboam, then in the senate, was appointed as a major in the Washington County battalion and later promoted to lieutenant colonel. These units were referred to as the "Corn Stalk Militia" since most of the recruits drilled with cornstalks instead of rifles due to funding shortages.

Children of Jereboam and Mary were: Joseph (1791-1826) m. Ellen Hensley died Louisiana; Joshua (1792-1842) m. Catherine Payne, daughter of Samuel Payne died Kansas; John (1793-1839) m. Susannah Beall d. Texas; Jereboam (1794-?) m. Mary Lindsay died Texas; Hannah (1795-1875) m. Adam Barr; Nancy (1796-1881) m. George Barr; Thomas (1797) died in Texas; Stephen (1799-1862) m. Mary Wyatt. Moved to Grayson Co., KY and died in Bowling Green, KY; Jonathan M. (1800-1883) m. Sallie Barr 2nd m. Dorcus Huff d. Breckinridge County; William (1806-1886) m. Mary Eliza Ford died Marion Co., KY; Sally (1808-1892) m. Elias Barr; Mary, M. Neil Black in 1834, no other records.

The last Beauchamp names in Marion County belong to William's family. William is buried at St. Matthews Church cemetery in Marion County with his son, Benedict, who died in 1902. The older son, Thomas, a Lebanon baker, according to the 1910 census, was married to a Josephine Corbett and there was a step daughter, Elizabeth Corbett. No records on William's other children Mary Jane, Susan, and Martha.

This branch of the Beauchamps in addition to their great presence in Washington, became early settlers in Green, Metcalfe, Barren, Warren, Simpson, Grayson, Hardin, Larue, Breckinridge, Daviess, and Hancock Counties in Kentucky and in Alabama, Mississippi, Louisiana, Texas, Illinois, Kansas, Oregon and Arkansas, Colorado and California.

In addition to the cited references, further reading on this family may be made in **The Beauchamp Story** by Stith Thompson in the Filson Club Quarterly, April 1954. Thompson is a Beauchamp descendant from Washington County. The Barr family history portrays much of the Beauchamps who married the Barrs and of Jonathan. Submitted by Col. Byron T. Cook, Perry, GA.

THOMAS WAYNE BEMISS, The progenitor of this family, Joseph Bemiss, native of England had a son, James, born Aug. 8, 1707 who settled early in Worthington, MA where he served in the Revolutionary War. His service ended when he was severely wounded at the Battle of Bennington, VT.

The third son of James Bemiss' four sons was Dr. John Bemiss, born Feb. 16, 1773. He graduated from the Plainfield Massachusetts Academy in March 1795 and two years later entered the office of Dr. Zachariah Standish as a student of surgery and medicine. He migrated to Bloomfield, KY in 1801 and was responsible for the town's name in honor of his wife, Elizabeth Bloomer, and his daughter Abigail's husband, Colonel Fielding Merrifield.

Dr. Bemiss had five sons: J. B., James M., William H., Harvey, Samuel M. and two daughters, Fanny and Abigail.

William H. Bemiss, great grandfather of the subject, along with his brothers, Dr. Samuel M. and James, served with the Confederate Army of Ten-

THE BEAUCHAMP FAMILY

By STITH THOMPSON

The American Beauchamps have always retained the old spelling, Beauchamp, with the pronunciation of "Beecham." Practically none has followed the example of the family of Sir Thomas Beecham in England. The difference between the spelling and pronunciation has, however, caused some inconvenience. The late speaker of the House of Representatives had to change his name from James Beauchamp Clark to Champ Clark because people were always confused about the pronunciation.

The family in America has never been outstanding in any way. It has produced no presidents, no great writers, and no leaders of industry, but it has been a good representative of a middle class family. It has had an almost successful candidate for the Presidency, Champ Clark. It has sent one prominent member to the gallows, Jeroboam Beauchamp, the principal in the notorious Beauchamp-Sharp tragedy in Kentucky in 1826. Mostly, however, it has been a family of farmers, small business men, and professional people.

When we find them first in America they are on the eastern shore of Maryland. The immigrant ancestor had come at the direct instance of Governor Calvert to take over the work of county clerk of the newly formed Somerset County in 1665. This Edmund Beauchamp remained as county clerk until his death in the early 1690's. The immigrant ancestor's father, John, was an important business man in London. He had helped finance a number of enterprises, among them the *Mayflower* to New England, and he had some investments in America. John Beauchamp's family had come from Northamptonshire, where they had been of the yeoman class, and were reasonably prosperous farmers. More remotely they went back to a younger branch of a noble British family. When we first run across them they are represented by one of the companions of William the Conqueror, who was granted land in 1066 and who established his family. The American Beauchamps come from the younger branch of this same family that produced the Earls of Warwick from the late twelfth to the middle fifteenth centuries.

Having been once settled in America it would seem that all connection and perhaps all memory of the British relationship vanished. The family remained as farmers in Maryland, primarily in Somerset County on the Eastern Shore, and some of the family are still to be found there. About 1760 a number of them removed to Kent County, Delaware, near Dover, where they remained for a generation. They fought in the American Revolution and have left some descendants in Delaware.

About 1790 most of them migrated to what one of them called "the wilds of Kentucky." The settlements in Kentucky were first in the Bluegrass country around Lexington and Versailles, but later certain of the branches of the family went into more southern parts of the state, part of them into Nelson County around Bloomfield and Bardstown, and part into the Owensboro area. They remained in Nelson County for a generation or two and some of them married there, and have left descendants through the female lines. The present writer is one of these. About 1830 the family began another general migration. Many of them went to southern Kentucky and remained there at least for some time. A considerable number are still in the southern counties of Kentucky, especially around Edmonton and Russellville. Later a number of families migrated to Texas, one or two to Mississippi and Louisiana, and at least one to Missouri in the 1840's and one among the earlier migrants to the Oregon country. There are thus descendants of the family in Texas and on the Pacific coast.

It will be seen that the Beauchamp family have followed all the main lines of migration since the earliest of the colonies. As a result of a study of these lines of migration, as well as investigation of the family itself, the present sketch has been prepared.

I became interested in the genealogy of the family about the turn of the century and it was possible for me to get interviews and letters from a number of persons who have long ago passed away. The men who came to Kentucky from Delaware were two brothers, Costin Beauchamp and Jesse Beauchamp, and all of the Kentucky Beauchamps are descended from one or other of these two. My own ancestor was Costin Beauchamp, who was born in 1738 in Somerset County, Maryland. He died at an age of beyond 100, but I do not know exactly when. In 1901 I talked to a great uncle, who told me that in his boyhood he had ridden on horseback behind old Costin Beauchamp. Thus the memory of three persons extends back to the 1740's.

A great deal of the information at the beginning of my inquiry came from Mrs. Kate B. Melone, a daughter of one of the Beauchamps who lived in Bardstown, Kentucky. As I had opportunity, I studied in genealogical libraries, primarily the Newberry Library in Chicago and the British Museum. I have worked in the public records in Northhamptonshire, in Somerset County, Maryland, and in Kent County, Delaware, as well as in various parts of Kentucky; and I have taken a good many trips to visit various branches of the family. The most important help came from Mrs. Mary W. Watkins, at that time of Owensboro, Kentucky. She had made much larger collections from the individual members of the family than I had, though perhaps I had more information from libraries. At her death she left me all of her papers, and the present article is a result of a combination of her work and my own. I have also been assisted by Judge Mark Beauchamp of Louisville and by Judge Tom Beauchamp of Austin, Texas. Certain records have also been made available by the Rev. Harvey Beauchamp of Dallas, Texas. Mrs. Rose Bowman of Portland, Oregon, also furnished the data for one of the branches of the family and thus filled out a section of the genealogy which up to that time had caused me a good deal of uncertainty.

I. HISTORY OF BEAUCHAMPS IN ENGLAND

There seems no reasonable doubt that the Beauchamps of Maryland are related to the well-known Beauchamp family of England. Some account of that family follows, with an indication of the probable relationship to the American family.

From Burke's *Extinct and Dormant Baronetage*:

"Among the most eminent Norman families in the train of the Conqueror was that of Beauchamp and amongst those that shared most liberally in the spoils of conquest."

The name Beauchamp originated from the castle of Beauchamp in the Cotentin part of the Barony of St. Denis le Geste, Normandy. The family was a branch of the Barons of St. Denis.

II. ENGLISH BEAUCHAMPS OF THE MIDDLE AGES

Most of the Beauchamp lines in the Middle Ages eventually became extinct or descended through female lines.

The originator of the family in England was Hugh de Beauchamp who came to England with William the Conqueror in 1066. He is listed on the Battle Abbey Roll. Hugh was given large estates in Hertford, Buckingham, and Bedfordshire. These estates are detailed in the Domesday Book (about 1090). His

relation to the various families of Beauchamp will be seen from the following charts:

Chart I. *Beauchamp, Earls of Warwick*

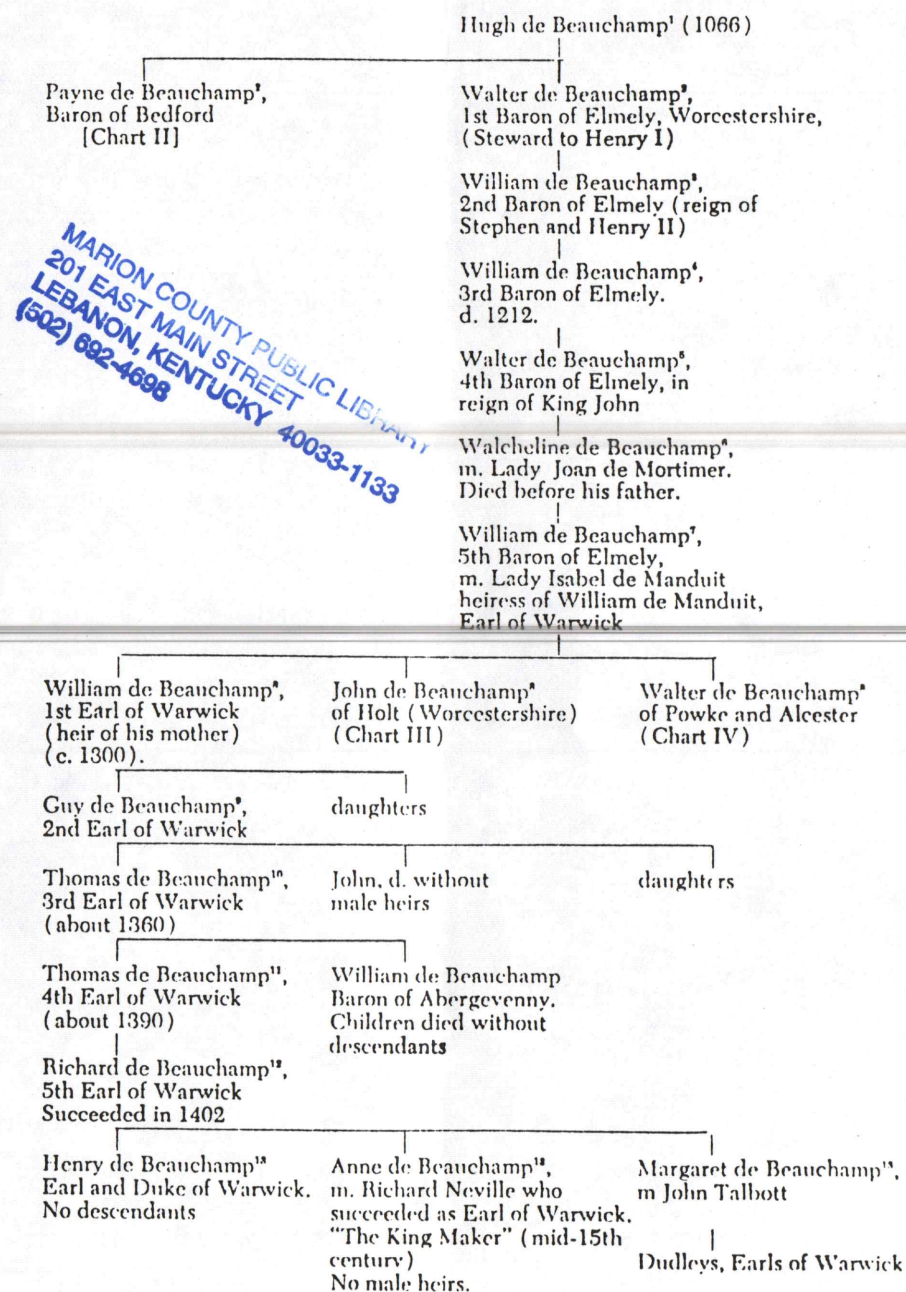
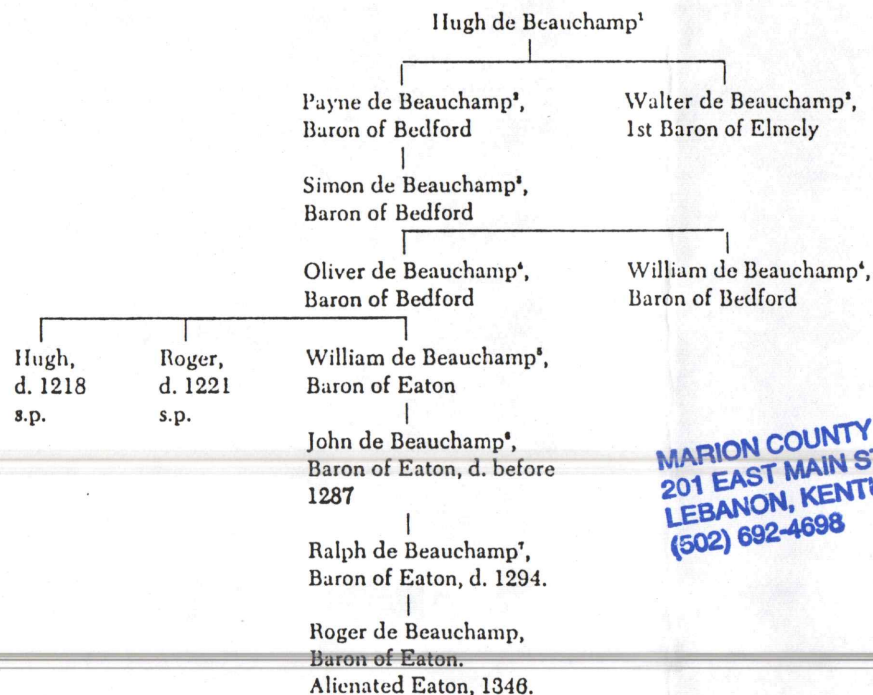
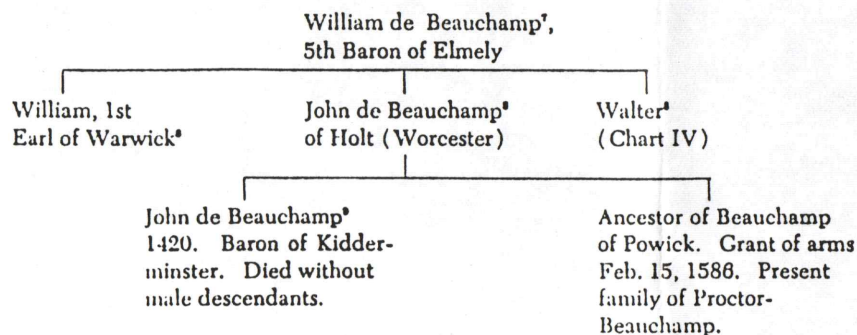
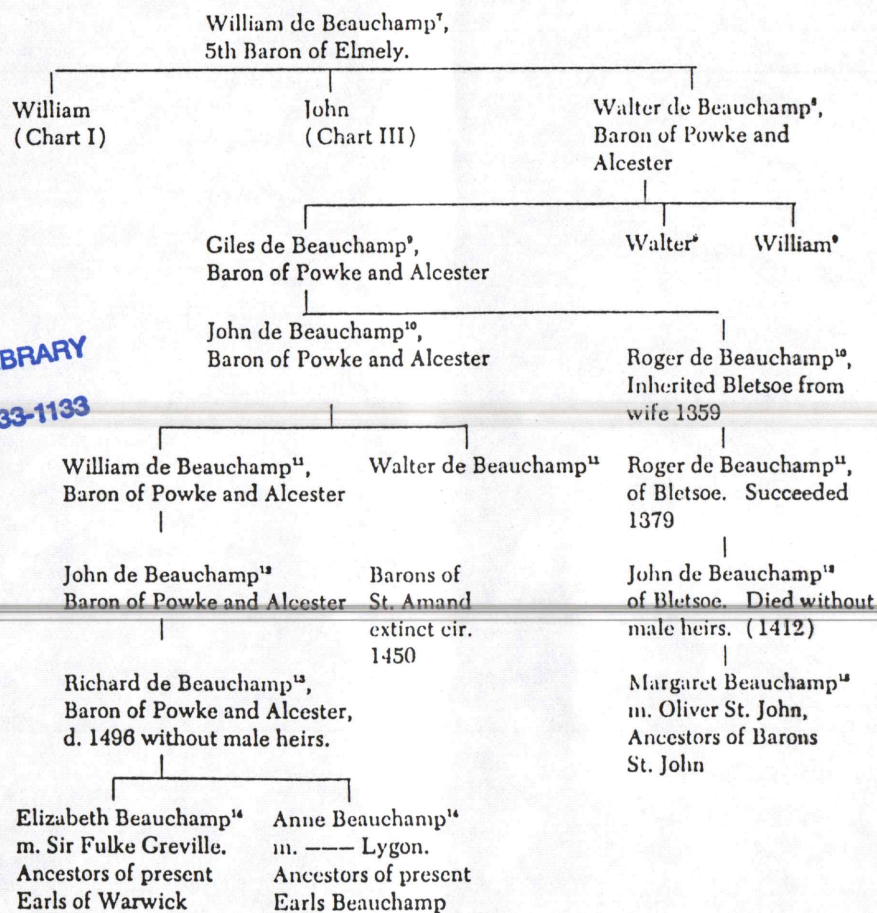


Chart II. *Beauchamps of Bedford and of Eaton*Chart III. *Beauchamps of Holt, Co. Worcester*

As will be seen by these charts, practically all the Beauchamps became extinct in the male line in the fourteenth and fifteenth centuries. The later representatives in the English nobility descend through daughters—the Dudleys and the Grevilles, Earls of Warwick in Elizabeth's time and today, the present Earls Beauchamp and the Proctor-Beauchamps.

But there are several younger sons on the charts who doubtless had descendants. At any rate a number of Beauchamp families appear in the English records of the sixteenth and later centuries. There are two large families in Cornwall and also a family at Burnham, Somerset, for which I have records beginning 1637.

The probable connection of the Beauchamps of Maryland with those of the Middle Ages is shown in a charter, found in the British Museum Manuscript Room, to Cosgrove, Northamptonshire, to Roger Beauchamp, 1 July, 37th of Edward III (1364). This is important since the Maryland family comes from Beauchamps of Cosgrove, Northampton. But their records begin only about 1530, so that there is a break of a century and a half.

Who was the Roger Beauchamp who acquired the manor of Cosgrove in 1364? Probably Roger Beauchamp who alienated Eaton, Bedfordshire in 1346. (But there is confusion among the genealogists between this Roger [the last name on Chart II] with Roger de Beauchamp of Bletsoe [Chart IV] whose grandson died without male heirs and who became ancestor of the Barons St. John.) It is certain that Roger (Chart II) who alienated Eaton in 1346 was on a committee for "The Good Parliament" of 1376. The case for the Charter to Cosgrove in 1364 having been to Roger Beauchamp of Eaton (Chart II) seems convincing to me. If this is true and if the same family was at Cosgrove in 1530, the relationship of the Maryland Beauchamps to the other families would seem to be displayed on Chart II.

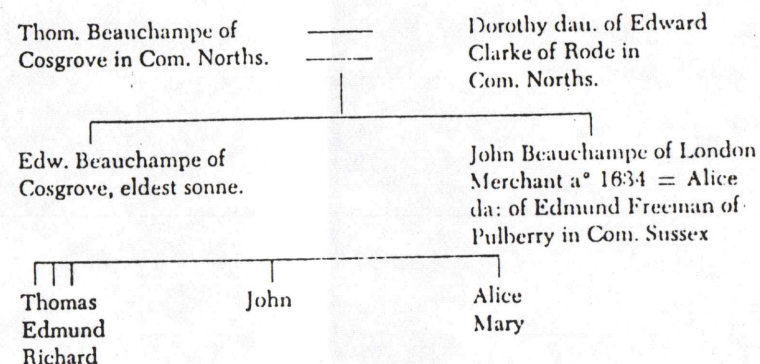
III. BEAUCHAMPS OF NORTHAMPTONSHIRE AND LONDON

The records for the Beauchamps at Cosgrove, Northamptonshire, begin with a will of John, February 16, 1532, who mentions his wife Margaret and son William.

The next are the wills of Thomas, March 10, 1545, and his wife Agnes, August 15, 1545. They mention his sister, Elizabeth, and their son John and a daughter.

This Thomas and John are doubtless related to each other and to Thomas next to be mentioned, but at present the records do not show how.

The first record with proved connections with the Maryland family is that of Thomas Beauchamp of Cosgrove who left a will December 27, 1613. He mentions his brothers Christopher and Robert (who also have wills at Northampton) and his wife Dorothy Clarke, daughter of Edward Clarke of Rode, Northamptonshire. His children are Edward (left will 1624), Thomas, Margaret, and John. In a herald's visitation (Visitations of London, Harleian Society, XV, p. 59) John Beauchamp gives his pedigree, which confirms this:



Thomas Beauchamp¹ of Cosgrove, Northampton, then, and his wife Dorothy Clarke, had sons Edward and

John Beauchamp² of London. The latter married in 1615, Alice Freeman, daughter of Edmund Freeman and his wife Alice Cole, of Pulborough, Sussex. The will of Edmund Freeman, May 30, 1623 (buried June 6, 1623 at Pulborough) mentions wife, daughter Alice Beauchamp, sons Edmund, William, and John. After the death of Edmund Freeman, the widow lived with her son-in-law John Beauchamp at Ryegate, where she died in 1651. (Will, 13 Nov. 1650). She wills her grandson Edmund Beauchamp £40.

Edmund Freeman, Jr., brother-in-law of John Beauchamp, went to Massachusetts and was prominent in affairs of the colony. He seems to have acted as a kind of agent for John Beauchamp, who was a merchant adventurer. (For correspondence between them, see Mary Turpin Layton, "Edmund Beauchamp of Maryland," *D.A.R. Magazine*, April, 1932.)

John Beauchamp was an influential member of the company that financed the *Mayflower*. He was granted two large tracts of land in Massachusetts. He also patented tracts of land in Virginia and there is evidence that he traveled to Virginia. His coat of arms was: sable a chevron argent between three lions' heads erased or, a crescent for difference.

The Register of the Parish Church of Pulborough, Sussex, gives the marriage of John Beauchamp and Alice Freeman (b. 1601), Dec. 27, 1615. It also lists the children as follows: John (d. 1615), Thomas, Alice (m. . . . Doggett), Mary (m. . . . Woolsey), Edmund, Richard, George, Elizabeth.

The Beauchamps of Maryland are descended from Edmund Beauchamp, son of John, merchant of London and grandson of Thomas of Cosgrove.

IV. BEAUCHAMPS OF MARYLAND AND DELAWARE

a. Edmund Beauchamp. That he was the son of John Beauchamp, merchant of London, is clear, first, because of his mention in John Beauchamp's Herald's Visitation statement; secondly the list of John Beauchamp's children in parish records; and thirdly, the fact that one of John Beauchamp's daughters married a Doggett and that one of Edmund Beauchamp's sons was named Doggett Beauchamp, evidently for his uncle.

Edmund Beauchamp in his will speaks of himself as "weaver, of London." He was in Maryland by 1665 since in that year he assigned fifty acres of land to William Smith. He was sent to Somerset County, Maryland, by Governor Charles Calvert in the spring of 1666 as a person well qualified to exercise the office of clerk to the court. This local court "entertayned" him on this high recommendation with the hope that he would carefully discharge the duties of so responsible an office. The letter from this court to Governor Calvert is under date of July 3, 1666. For a short time Edmund Beauchamp occupied the office of clerk of court for the entire Eastern Shore, but on August 22, 1666, Somerset County was established and from that time with the exception of a few months, he was clerk of Somerset County until his death in 1691. I have seen the records which he made and agree entirely with the estimate made by Clayton Torrence, author of *Old Somerset on the Eastern Shore of Maryland* (p. 333): "Anyone who has occasion to make careful study and investigation of the records of Somerset Court from its beginning throughout Beauchamp's years of service as clerk will fully realize the care and thought which this early worthy bestowed upon the duties of his office. A more splendidly kept set of records of court proceedings and deeds cannot, we believe, be found elsewhere during the early colonial period. He was a veritable master of his craft."

On June 11, 1668, he married Sarah, daughter of Ambrose and Mary Dixon of Annemessex. Ambrose Dixon had come to Northampton County, Virginia in 1649, and his wife had joined him in 1652. He had joined the Quakers and had been persecuted in Virginia for his associations with them. He went to Maryland before January, 1661/2. Dixon's home, "Dixon's Choice," on the south side of the Great Annemessex River was a center for Quaker activities in the early years of the settlement. He died April 12, 1687, mentioning in his will his son-in-law, Edmund Beauchamp. For a good account of Ambrose Dixon, see Torrence, *Old Somerset*, pp. 302 ff.

On June 30, 1668, Edmund Beauchamp purchased 300 acres of land called "Contention" lying at the head of the Great Annemessex River (see Archives of Maryland, vol. 54). In October, 1669, he conveyed this land to his wife "Sarah Beauchamp, alias Dixon, daughter of Ambrose and Mary Dixon." "Contention" was the home of the Beauchamps for more than a century.

Edmund Beauchamp was a member of the Church of England, and his wife and three of their children were among the first to be baptized into that church in Somerset County. This happened in 1671, 1674, and 1677.

The record of Edmund Beauchamp's children appears in the parish records of Coventry Parish church and also in the Somerset County court record book IKL. The same list appears in his will. This will was not recorded in the Register of Wills Office at Princess Ann, but was found in an unused alcove of the courthouse there by Mrs. Layton of Washington, D. C. An abstract of the will follows:

"I, Edmund Beauchamp, weaver of London, and at present writing clerk of the county court of Somerset County.

To wife Sarah, the land where she now dwells during natural life or widowhood, land lying between land of son Thomas, bounds of land of son John. Also household furniture, etc.

To son Thomas Beauchamp, personality.

To son Edmund, part of my land called "Contention," (50 acres) beginning at the corner tree of son Thomas' land by conveyance made over to him by myself and wife, etc.

To son Edmund, personality.

To Patience Beauchamp, twelve pounds sterling to be paid her at age or day of marriage.

Balance of estate to be equally divided between my son Thomas Beauchamp, my son Edmund Beauchamp, my daughter Alice Beauchamp, my son John Beauchamp, my son Doggett Beauchamp, my son Edward Beauchamp, and my son Robert Beauchamp.

Dated 10 April, 1691."

The widow, Sarah Beauchamp, later married John Heath of Somerset County.

Deed of gift of land called "Discovery" (150 a.) from William Beauchamp to his brother Robert, Somerset County, Bk. AZ. 018, p. 162, June 18, 1734. Deeded back with one shilling consideration on April 1, 1745. His children are listed in Coventry Parish records of Rehoboth P. E. Church, near Pocomoke City, Somerset County, and also in his will of April 3, 1772 (Kent Co., Delaware). Also in a deed from Costin Beauchamp to Jeroboam Beauchamp (Kent Co., Del., Sept. 1, 1790) Costin mentions "Robert Beauchamp, father of the said Costin B., Levi B., and Grace Ford, late Grace Handy." Jeroboam sold this land "St. Collum" to Levi Hatfield Oct. 24, 1794 and gave the same names. These children were:

V. COSTIN BEAUCHAMP AND HIS DESCENDANTS

In 1783 Costin and Charity his wife deed to Joshua Beauchamp, Kent Co., Del.; Woodford Co., Ky., July 1791 [Kk. B. p. 4] "this day came Costin Beauchamp late of Delaware and listed his Negroes.") Appears on tax lists of Fayette Co., Ky. for 1792-1796. Said to have gone to Nelson Co., Ky. later. Records in Nelson and Washington Cos., Ky. Lived after death of his son Newell, who mentions his father in his will of 1825.

There are numerous transactions in Delaware between him and his relatives.

He married (1) Kitty Newell and (2) Charity Robinson.

A marriage of Costin Beauchamp to Mrs. Nancy Graham is recorded in Washington Co., Ky. for 1808, but there is no tradition in the family concerning this marriage. He is recorded in the census of 1810 in Washington Co. with two males, 16-28, one female under 10, one 10-26, one over 45. (Is this Nancy's family?) He bought 666 2/3 acres in Shelby Co. in 1815. He is said to have died at Raywick, now Marion Co., Ky., at a great age—reputedly 107. I talked to an old man in 1901 (my great-uncle Henry McClaskey) who remembered riding behind him on a horse. It was nice to talk to you a couple of weeks ago. We talked about the Beauchamps. I did try the Clerk's office to find if my target, Thomas Beauchamp, the Lebanon baker of early 1900s had adate of marriage. I found he had two but not the one I am looking for.

So allow me to get in line for your volunteers to check some census records for me.

First let me ask you if you have the Enterprise or whatever name the local paper had in 1886 in your records. If you do I would like a copy of the obit on William Beauchamp who died Sept 21, 1886. You had previously looked up that date for me in the cemetery records. If you do not have such files and think there might be some at the newspaper office let me know.

On the census. We have the 1860 and 1880 records at the local generalogy shop. I am trying to trace Thomas Beauchamp so in the 1870 census, one would probably find him at home with William Beauchamp in New Market district. Have the researcher give me all the information published on the family then.

For the 1890 census, I am looking for Thomas Beauchamp family and especially Herbert Francis Beauchamp. If possible let me have a copy of that family. They should still be in New Market district but if not in Lebanon. Any stray Beauchamps list them. I think there may be a John and a Ben Beauchamp as Thomas' sons.

The same for the 1900 census and Thomas should be in Lebanon baking bread. He will have a new wife then, Would like a copy.

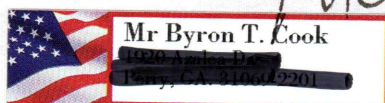
In the 1920 census, I have the 1910 data, the look there is to see if Thomas is still living or that we can set his death during that decade. He should be in Lebanon if living.

Thomas Marion Beauchamp, b: abt 1849 at New Market, Marion, KY, D: Jan 14, 1926 at New Market, Marion, KY. One living child of this marriage, Herbert Francis Beauchamp, born, March 9, 1880 at New Market, Marion, KY. Herbert Francis Beauchamp was my Grandfather. Thomas Marion Beauchamp, son of William Beauchamp and Mary E. Ford, William son of Jeroboam Beauchamp. They were Catholic.

I have a prayer book that belonged to a Louisa J. Buckman. This could be Martha's Mother. Nothing else known about Louisa.

There is a John Buckman, Washington County, KY Deeds 1792-1834 listed and a Jeroboam Beauchamp, Grantor (J 92 Deed) Jeroboam would be Thomas Marion Beauchamp's Grandfather, so there may be a connection there.

The sister of John Jr. and Bernard, who married a Patteson, removed with her husband, Col. Nelson Patteson, to Pulaski, Giles County. The old settlement (now gone) and the old graveyard are about 200 yards east of the eastern limit of Madison Street. Col. Patteson had a son, Bernard Markham Patteson, who died in West Tennessee and a grandson, Bernard Markham Patteson (son of James) now an old man, at Paris, Texas.

There are yet Markhams in Chesterfield County.

Callaway

Col. Richard Callaway was one of Kentucky's noted pioneers. I am a descendant of Col. Callaway through his second daughter, Fanny, who married Capt. John Holder, a noted pioneer and Indian fighter. My mother was the youngest child of Fanny Holder, nee Callaway. Flanders Callaway's descendants are many and

some still are found in Saint Charles County, Missouri. A daughter married a Mr. French, father of the late Judge Richard French, of Mount Sterling, Kentucky. A son, Richard Callaway, Jr., represented Madison County, Kentucky, in the legislature several times in the early days of the state and afterward moved to Franklin County, Tennessee; where he died at a ripe old age, leaving many descendants in the states of Mississippi and Alabama

Van Bibber

John and Peter Van Bibber came with the army from Greenbriar, and settled in the valley and became ancestors of a prominent family. Matthias Van Bibber, called Tice, was a companion of Boone and a chain carrier. He became the father-in-law of Jesse Boone, Col. Andrew Donnally, Col. John Reynolds, and Mr. Goodrich Slaughter, and later, through Jesse Boone's daughter, grandfather-in-law of Gov. Boggs, of Missouri, and Warner, Congressman from Missouri. Tice had a son, David.

Richardson

My great-grandfather, Samuel Price, married a Miss Richardson, in Virginia. They moved from Virginia to Versailles, Kentucky and died there about 1820. Great-great-grandfather Richardson's parents were members of Lord Baltimore's colony in Maryland.

Beauchamp

Causton Beauchamp and a brother came to America together. Causton settling at Snow Hill, Maryland, and the brother in the South, probably in Louisiana. Causton afterward moved to Delaware, then to Kentucky and is supposed to be buried at Raywick, Marion County, Kentucky. He married Elizabeth Newell, to whom were born several children. He was not a patriot of the Revolution, but a Tory; loyal to King George. He had his coat of arms and loved to talk of his distinguished ancestry and of the fortune that would descend to his posterity from the old country; also of his knowledge of the two "missing links."



The conjectural drawing at left portrays the killing of Solomon P. Sharp by Jereboam O. Beauchamp on November 7, 1825, in Frankfort. Beauchamp, a young man from Simpson County, claimed that his wife, Ann Cook, had been seduced by Sharp who was then attorney general of Kentucky. While in jail, Beauchamp entered into a double suicide plot with his wife. She died, but Beauchamp lived long enough to be publicly hanged in the city where his crime was committed.

The couple were buried in a single grave in Bloomfield under a marker with an inscription romantic enough to assure a continued interest in the tragedy. The affair became the subject of several novels, including Robert Penn Warren's *World Enough and Time*.

Confederate guerrilla Champ Ferguson, shown at left with a guard, was accused at his trial in Nashville of having killed fifty-three persons. Many other victims were not mentioned in the charges. He was hanged October 20, 1865.

Angry mobs destroyed two antislavery newspaper offices—Cassius Clay's *The True American* in Lexington (August 18, 1845) and *The True South* in Newport (October 28–29, 1859).



Genealogy From The Long Ago

(OLD SCRAPBOOK - 1890)

Editor's Note: We have come across an interesting collection of old clippings dealing with Kentucky family history. Since these clippings are over 100 years old, your editor feels they will be of interest to many of our readers. We will continue this column each month until the supply is gone.

Lewis

Thomas Lewis was born in Fairfax County, Virginia, on May 8, 1749, and married Elizabeth Payne on October 27, 1773. Their children were Nancy, born in 1774, married James Garrard, son of Governor Garrard, of Kentucky, and died in 1835; Sally, born 1776, married first Gen. Green Clay, second Col. Jephtha Dudley, and died in 1867; Hector P. Lewis, born 1778, died 1857; Asa R., born 1781, died 1850; Betsey, both 1782, married Col. Jepsey Dudley, and died 1807, leaving an infant son, Edward Ambrose Dudley. Col. Jephtha Dudley married, secondly, his sister-in-law, the widow of Gen. Green Clay; Edward Lewis, born 1785, died 1808; Hetty, born 1787, married Henry Conyers Payne, died 1829; Stephen O. Conyers Payne, died 1829; Stephen O., born 1789, died 1870; Polly, born 1792, died 1792; Thornton, born 1794, died 1872; Sophia, born 1786, married Rev. John T. Johnson, died 1849; Alpheus, born 1799, died 1865; Douglas Payne, born 1804, died 1867. Thomas Lewis died in September 1800, and his widow, Elizabeth Lewis, died March 24, 1827.

Lee

The Henry Lee who was born in Fauquier County in 1758, who represented Bourbon County in the Virginia Convention of 1788 and voted against the ratification of the Federal Constitution, and who died in Mason County, Kentucky, about 1844, was one of the sons of Stephen Lee. His mother was a widow Dunn when Stephen Lee married her for his third wife. Stephen Lee came to Kentucky, settled in Mason County, died, and was buried there, and his will

is on record in Maysville. Of the antecedents of Stephen Lee, nothing whatever is known by any of his descendants. By his three wives he had many children and their descendants are numerous in Mason, Fleming, and Lewis Counties. It is not true that the Henry Lee referred to had a sister who married Ambrose Madison, a younger brother of President James Madison. The wife of Ambrose Madison was Mary Willis Lee. Her father was the second Hancock Lee and her mother was Mary Willis, daughter of Henry Willis, of Fredricksburg, by his first wife, Anne Alexander, widow of John Smith. The second Hancock Lee lived at Lee's Spring, in Fauquier County, now known as Warrenton White Sulphur. His oldest son, Hancock Lee, was with his cousins, Hancock and Richard Taylor, in their expeditions down the Ohio and Mississippi in 1769. His second son, Willis Lee, was in Kentucky in 1774 and was killed by the Indians near Frankfort in 1776. Another one of his sons was Maj. John Lee of the Revolution, who settled in Woodford County in 1794, died there in 1802.

Morton

Jacob Morton was born in Stockholm, Sweden. His son, Elijah Morton, married Elizabeth Hawkins, it is believed. Their children were (1) George, (2) William, (3) Joseph, (4) John, (5) Sallie Beldsae, (6) Frankie Terrell, and (7) Betsy Qashenberry. William Morton married _____. Children were (1) Charles, (2) George, (3) Abram, United States Marshal, assisted in the arrest of Aaron Burr; (4) John Hite, father of John P. Morton, the Louisville Publisher; and (5) Gabriel I. John Peak, died in Ohio ca. 1835. All his family died with

milk sickness, except his wife and two children, Alexander and Jane. The mother and two surviving children moved back to Nelson County, Kentucky. The son, Alexander Peak, went to Illinois about the year of 1841, and married there. The daughter, Jane Peak, was the second wife of Isaac Phillips, who lived in Washington County, Kentucky.

Beauchamp

Costen (or Causton) Beauchamp and a brother came to America together. Causton settled in Snow Hill, Maryland, and his brother in the South, possibly Louisiana. Causton afterward moved to Delaware, then to Kentucky and is supposed to be buried at Raywick, Marion County, Kentucky. He married Elizabeth Newell, to whom were born several children; was not a patriot of the Revolution, but a Tory, loyal to King George. He had his coat of arms and loved to talk of his distinguished ancestry and of the fortune that would descend to his posterity from the old country and of his knowledge of the two "missing links."

Johnson

I quote from a letter of Cave Johnson P. M. G. under Polk to his three sons, J. Hickman, Thomas Dickson and Polk Grundy: "Thomas Johnson, father of Cave Johnson, married Mary Noel, the daughter of Mary Noel; whose husband was killed during the Revolutionary War in Virginia at the Battle of Yorktown. She removed with her kinsman, the Rev. Richard Cave, to Kentucky in 1789, with her daughters, Mary and Roeanna Noel. I do not know the relationship existing between Mary Noel and the Rev. Richard Cave (were probably brother and sister). Mary and her two daughters were active members of his church. He was prominent and influential in the Baptist church. It is probable that the Johnsons of Kentucky were connected with the family of Richard Cave through Col. Richard M. Johnson, of Kentucky, and myself were unable to trace the relationship satisfactorily. Richard M. Johnson was given the name Richard after Richard Cave, whilst my mother gave me the name Cave after her much-beloved and venerated grandfather, Col. Cave Johnson of Kentucky, uncle of Richard M. Johnson, also for this name."
