My great-grandfather William Henry Bowman (born 2/14/1838 Washington Co., Ky.) son of William B. Bowman (born 1818 Ky.) and Francis (Francy) Harley. William B. Bowman's father Jacob Bowman (born 1770 to 1780 Ky.) I don't know who Jacob's father was yet.

I located William H. Bowman (above) on the 1860 Washington Co., Ky. census living with his parents. And for the next 17 years I am unable to locate him until 3/22/1877 in Jackson Co. In. when he marries his 2nd wife Sarah Isabell "Bell" Smith (born 1858 Clark Co. In.) (She is the daughter of William Smith and Margaret _____, both from In.). William H. and 2nd wife Sarah are listed on the 1880 Jackson Co. In. census with 3 sons from his 1st marriage James W. age 16; John M. age 13; Jerome age 8; and Thomas E. age 1 their son and my grandfather.

I've been told William Henry Bowman served in the Civil War for Union Army (but could be Confederate army as stories go).

Several of my relatives married in Meigs Co Ky and Washington Co. Ky. I have all of Wm. H. brother & sister except for Mary J. Bowman and John C. Bowman.

I found a marriage record for a William H. Bowman to Elizabeth Doolittle in Meigs County records on July 20, 1856. Do not know if this is my gr-grandfather, wish it had their age and their parents listed.

Elizabeth Doolittle Bowman must be listed on 1860 Census with her parents? Since William H. is listed with his parents on the 1860 Washington Co. Ky. Census. I wonder about 1870 Census also for them.

Anchorage. By Leone W. Hallenberg. Edited by Ruth Sanders and Sara Campbell. [Anchorage, Ky.: 1959] 225 pp. \$4.00.

The sub-title of this book, A Casual Gathering of Facts and Stories from the Past and Present of a Unique Kentucky Town, stimulates interest at once, and the colorful, sparkling style of the author holds the interest to the end. The importance of the book to the genealogist or historian, however, is that the facts presented are accurate and well documented. A map showing the location of some of the old landmarks, and many illustrations of homes, churches, schools add to the value of the book.

In the author's foreword we read that "The town of Anchorage was not incorporated until 1878 but as early as 1860, under the name of 'Hobbs' Station', it already boasted a general store, a railroad station housing the S. Post Office, a blacksmith shop, a meat market, and a scattering of spacious country homes. . . ." A chapter is devoted to Edward Dorsey Hobbs, the founder of Anchorage, the town having first been called after Mr. Hobbs. Steamboat Captain James W. Goslee, retired from the river, cast the anchor from his last boat, a tamara, on the lawn of his home and christened his estate "Anchorage". A short genealogical sketch of Captain Goslee is included in the chapter entitled "Early Families." The old stone spring house built by Richard Chenoweth in 1785 and the massacre which took place there in 1789 are described. Public institutions and business houses, the part played by the railroad in the early development of the village, the churches of Anchorage, including Hobbs Memorial Chapel, are discussed. In the appendices one will find excerpts from Minutes of the Town Board, a list of Anchorage school superintendents, tombstone inscriptions, and a bibliography. Copies may be obtained from The Anchorage Press, Anchorage, Kentucky.

five daughters, Sally, married Robert Warring, second married Bridges; Maris, married Nicholas Lafon; Hannah, married Richard Price; Lucy, married first William Warring, second William Sthreshly; Cordelia, married Childs Terrill. The last four came to Kentucky at an early day and their descendants scattered over the entire country.

Talbott

One Samuel Talbott lived in Fairfax County, Va. He married Mary Magdalene DeMovill. Their children were DeMorrill Talbott, born July 25, 1754; Samuel, March 17, 1756; Presley, April 9, 1758; Nancy, December 28, 1760; Jemina, October 15, 1762; Rodham, February 15, 1764; Sampson, November 27 1767; Hannah N., January 11, 1770; Katherine, December 3, 1772; Ann, May 27, 1774. Samuel Talbott died December 31, 1777. His wife, Mary DeMovill Talbott, died July 2, 1791, in Virginia. Several of their children came to Bourbon County, Kentucky.

Bowman-Hite

Joist Hite and his party were the first emigrants to settle west of the Blue Ridge. He held in his own right a grant from King George for 40,000 acres of land and was a fourth owner in another grant of 100,000 acres. Hite had a long contested suit with Lord Fairfax, which his descendants won, after all the original parties to the suit were dead.

Mary, the daughter of Joist Hite, married George Bowman prior to 1722. Of their children, Maj. Joseph, Isaac, John and Abraham and their son-in-law, Isaac Rudell, were Revolutionary soldiers. Maj. Joseph, of the Illinois campaign, died in the fort at Vincennes, John was the first County Lieutenant of Kentucky, virtually Governor, and Abram was Colonel of the Eighth Virginia regiment.

Two other daughters of Joist Hite married Jacob Chrisman and Paul Froman and came with him from Pennsylvania to the valley of Virginia in 1732. George Bowman's will dated 1764, probated 1768. Hite settled five miles south of what is now Winchester, Va. His son-in-law, Jacob Chrisman, at what is now called, Chrisman Springs; Bowman six miles farther south, and Froman

nine miles northwest of Bowman.

Jacob, the son of Joist Hite, married a sister of Col. James Madison, the father of the President. Maj. Isaac Hite, of Bell Grove, Va., grandson of

Joist, married a sister of President Madison's, Sarah Hite; granddaughter of Joist, became the wife of Jonathan Clark, Colonel in the Revolution and brother of Gen. George Rogers Clark.

1671. His will is dated January 8, and proved March 13, 1671, at the Lancaster courthouse. He left the bulk of his estate to his only son, Hugh, (another son, William, having died probably before the father). The son, Hugh, was J. P. in Lancaster in 1706. In June 1719 another Hugh, no doubt son of the second one, makes a conveyance to his brother, William. September 13, 1726, there is a deed from Hugh Brent to his children William, Hugh, Katharine, and Elizabeth. In 1743 another Hugh Brent was sheriff of Lancaster. There are also marriage bonds filed in that county as follows: James Brent and Catharine Martin, July 26, 1724, Hugh, security; William Brent and Margaret Haines, January 7, 1723-24, James Hains, Jr., security; William Brent and Letita Wale, April 1735; William Brent and Judith King, widow, May 1, 1753; James Brent and Sarah Currell, November 4, 1768; and others too numerous to mention; although I have given all where the names of William and James occur. Whether these Brents were descended from Giles, the immigrant, who came to Maryland in 1637-38, is not yet established, but the fact that Giles' sister, Miss Margaret Brent, who has been called the most-noted woman in colonial history, herself patented lands in Lancaster the same year Hugh died, shows some connection.

Walker

John Walker was born in King and Queen County, Virginia, in 1709. He married a Baylor. One daughter married a Semple; they had other children. Robert B. Semple, the Baptist minister and Baylor Semple, of *The Fredericksburg News*, were descendants. George Semple, a lawyer who came to Louisville early in the 19th century, may have been a descendant of John Walker. A Buckner from Caroline County, Virginia, married into the Walker family.

Bowman

Grizel Greenlee, daughter of James Greenlee and Mary E. McDowell, eldest daughter of Ephraim McDowell of London-derry fame, married first Capt. John Bowman, the Indian fighter, killed at Ramsour's Mills, June 20, 1780. In the case of Bowman vs. Barlett, et al., three Marshall, page 96, Kentucky reports

Court of Appeals, a witness swears that John Bowman is the son and sole heir of Col. John Bowman mentioned above as Capt. John Bowman, and to be at that time between 45 and 50 years of age. Cannot give names of descendants of Abraham and Joseph, brothers of old John B., Fayette, Mercer, and Boyle counties, Kentucky.

Pope

Elijah Backus, of New London, Connecticut, born 1759, died 1811, married in 1784, Lucretia, widow of Daniel Tracy and daughter of Russell Hubbard, son of Daniel Hubbard, son of the Rev. John Hubbard, of Jamaica, and his wife, Mabel Russell (of royal descent). Elijah and Lucretia Backus had, first, Lucretia, who married Judge Nathaniel Pope of Kaskaskia, Illinois, born in Louisville, Kentucky, 1784, and died in 1850, while United States District Judge in Illinois, and had first, Maj. Gen. John Pope, United States Army, born March 13, 1823, married, in 1860, the daughter of Valentine B. Horton of Pomeroy, Ohio, and had Horton, John, Francis, and Lucretia.

Second, William Pope, of Springfield, Illinois, born 1816, died in 1853, married Elizabeth Douglas Pope, United States Army, died 1880; John; Cornelia; Lucretia; and Nathaniel.

Third, Elizabeth, married Dr. Thomas Pope of Alton, had issue. Fourth, Penelope, married Beverly Allen of St. Louis, Missouri, had issue. Fifth, Cynthia, married James E. Yeatman of St. Louis, Missouri, had issue. Sixth, Lucretia, married Thomas Yeatman of New Haven, had issue.

Livingston

The direct male line of the old Lord Livingston being extinct, the line of male descent now (both in Scotland and Virginia) lies with the descendants of Rev. Alexander Livingston, rector of Monabrac 1561-1598. His ancestor, name unknown, was killed at Pinkie, 1547, being a younger son of the fourth Lord Livingston. His son, Rev. William Livingston, of Lanark, 1576-1641, was the father of Rev. John of Ancrum, 1603-1672, who had three sons William and James, merchants of Edinburgh; and Robert, founder of Livingston Manor, New York. The latter was born 1654, died 1728; emigrated to America in 1678.

His nephew, Robert (son of John), came over in 1687. These two left numerous descendants.

Hopson

Col. Joseph Hopson, son of Henry and Martha Neville, had by his wife, Sallie Boyd, of a wealthy and influential family of Virginia; George, Morgan, Samuel, Joshua, Henry, and Mildred. Dr. Samuel Hopson, third son, married Sallie J. Clark and was the father of the late gifted, Winthrop Hartley Hopson, minister of the Christian Church. Dr. Henry Hopson died in Paris, Kentucky, and left one son, Joseph, of Lexington. Joseph Hopson of St. Mathews, Kentucky, is the son of Joshua Hopson of Trigg County and the grandson of Morgan, the son of Col. Joseph, whose ancestors are wanted. Dr. Winthrop's only child is Mrs. R. L. Cave of Nashville, Tennessee.

Napier

There are Napiers in Goochland, formed from Henrico County in 1827, at an early period. Bouth Napier and Sarah, his wife, conveyed land in Goochland County in 1728, patentee of land in Henrico County, 1719. They probably died in Albemarle County. Robert Napier, Jr., and Mary, his wife, conveyed land in Goochland, in 1737. He had a son, Patrick and daughter, Frances. Rene Napier died in 1751, and in his will mentions his wife, Wene, and sons, John, Rene, and Champion; daughters, Cole and Mary. He had a brother, Patrick Napier, and cousin, Bouth Woodson. Court records of Henrico and Albemarle counties should be consulted.

Homes Built by Royal Bowman

Located at the corner of East Main Street and Forrest Street, this brick home was built @ 1850's for W. W. Wathen by his father's brother in law, Royal Bowman. It was originally known as the "Rose Cottage."

The old Jackson house, located on east Main Street, was built for Thomas and Nancy Rodman Jackson. The house was built @ 1830's.

"Myrtledene" located on north Spalding Avenue was built in 1833 for Benedict and Elizabeth McElroy Spalding.

No longer standing, but located where the Marion County Public Library is, was the home of Royal Bowman. It was built before the Civil War and the last tenant was Walter Beswick.

This house built @ 1840 was built for David Phillips. Miss Edmonds' article indicated that Phillips probably built the house. Later Mr. Dehringer, wrote that the home was built by Royal Bowman. There are similiar features in this house, the house next door (see bottom photograph), the Jackson house and the house Royal Bowman lived in.

Paul Lige Bowman, 79

Paul Lige Bowman, 79, of 2298 Beechland Road, Springfield, died at 6:15 a.m., Sunday, August 29, 1993 at the Ephraim McDowell Regional Medical Center in Danville.

He was born in Bell County on Sept. 17, 1913 to the late Frank and Josie Wilburn Bowman.

In 1955 he moved from Bell County to Washington County and was employed by ICI America, Inc. in Charlestown, Ind., until his retirement in 1975. Following retirement he maintained the grounds of Peter Cemetery in Mackville until 1988.

Survivors include his wife, Mrs. Cleta Webb Bowman, two sons, Paul W. Bowman of Charlestown, Ind., and Phillip Bowman, of Springfield; five daughters, Mrs. Kenneth (Mary Sue) Lanham of Mt. Washington, Brenda Marks of Lexington,

Sharon Pinkston, Mrs. Lynn (Rhonda) Holderman and Mrs. Mike (Betty) Grigsby, all of Springfield.

Also surviving are eighteen grandchildren, ten great-grandchildren and two sisters, Mrs. Ann Lawson of Middlesboro and Thena Bowman of Virginia.

Funeral services were held at 2 p.m., Tuesday, Aug. 31 at the Carey and Son Funeral Home with the Rev. Chuck Robinson, pastor of the New Harmony Baptist Church, officiating.

Burial was in the Peter Cemetery at Mackville.

Serving as pallbearers were grandsons, Timothy Dale Bowman, Kenneth Lanham, Jr., Craig Lanham, Jerry Bowman, Patrick Grigsby, Christopher Holderman and Timothy Michael Bowman.

I looked through our collection of genealogy for the name of William Henry Bowman. I found only one reference to a William Henry Bowman. It was in the book: "Index of Confederate Pension Applications; Index to Soldier's Applications for Pension & Widows' Indigent Pension Applications." Entry:

There was a William Bowman, Private, enlisted Sep. 2, 1862, Lexington, Ky. in Company H. Fifth Regiment Cavalry - Kentucky Volunteers - Confederate States Army. (Source - "Report of the Adjutant General of the State of Kentucky - Civil war - Confederate - Vol.I", pg.654).

There were several William Bowmans listed in the "Report of Adjutant General..... - Union", but none were from this area or any close county.

We have a book on the "Major William Boarman, Charles County, Maryland (1630-1709) His Descendants, Boarman/Bowman and Allied Families" by Mary Louise Donnelly. I checked the index for your William Henry and William B. and did not find them listed.

Since you found William Henry on the 1860 Washington County Census, probably he was never in Marion County. I think you would be more likely to find something on him in Washington County than Marion.

I wish I could have been more helpful. Good luck in your research.



Dear Mary Ella,

Dear Dr. Drury,

I have begun to collect Bowman information for you but there is more that I have not reviewed. However, I have a consulting job in New Mexico and won't be able to work on your information again until after May 15th. I send you what I have, because if you are like me you are anxious to learn all that you can about your ancestors.

You didn't mention it and I wondered if you knew that Royal Bowman was considered a master builder. Master builders in the early and mid 1800's would be like architects today. He built a number of houses in Lebanon and several of them are still standing. I believe I have some photographs of some of the homes. If I do, you want me to make copies of them for you?

Mary A. Riney is the daughter of Eleanor and Basil Riney. In the will of Benedict Spalding, he mentions his daughter Eleanor Riney. Also on her marriage license it lists Eleanor Riney as her mother. Basil Riney is probably the son of Thomas Riney. Thomas lists his children in his will and I believe Batsel is a typing or transcription error for Basil.

Royal Bowman is probably the son of Thomas and Catherine Bowman but I have not been able to locate any proof of this. There is a Boarman/Bowman Book in our library but it mentions a Royal Bowman as belonging to another line that was not research for this book. There was no information in the Riney, Bowman, Drury, Walston, Gribbins family files that helped. Most just contained requests with little or no attached information.

I am really struggling with the Walston/Gribbins/Drury lines with no information to date.

I went through the baptisms records at St. Augustine Church, Lebanon, Kentucky. I copied all the Bowmans and Moores that were Royal's children, grandchildren and may have picked up some great grandchildren. Looks like I have some different dates of births and some different names.

Dear Mary Ella,

I hope that you were able to catch up on all your work and enjoyed happy holidays. I've kept busy learning the features of my new computer. I had mentioned James E. Drury as a possible relative. Please don't spend time seeking him out. I mentioned him only if you came across the name in your other searches.

I would like to obtain more information of the Bowman family in Casey County. I again reviewed the census of 1830 Washington and there was only one Royal Bowman. I considered after reading the "Bowman Family" information from Casey County, that there had been two Royals, father and son. So this was the builder and my great, great, grandfather.

The "Bowman Tree" information from Casy County you sent is a bit confusing. Is there a census of 1800 and 1810? They might clarify if Billie had "two brothers" or could this have been two sons? Royal was born in 1802 and Winston in 1805. Both of Royal's parents were born in Virginia. The Winston Bowman family records or the census might show more about Billie and Winston and perhaps the parents of Billie. I believe that I have told you that I have located Royal Bowman in Virginia 1756 and 1764, which could be the grandfather.

I have received Civil War records of a George W. Bowman who enlisted in Louisville June 1861 Co. H 1st KY Infantry and William M. Bowman who enlisted 9-10-1862 at Lebanon, KY, captured 7-24-1863 at Zanesville, OH. No record of James A. Bowman found. Would they be buried, as might the other Bowmans, at St. Augustine's or the Lebanon National Cemetery? I notice on the map, a Glasscock Grade School. Is this named after one of your relatives?



The latest information and pictures you sent were beyond my expectations. Perhaps this carpenter-contractor portion of my gene pool aided me in my specialty of Orthopaedic Surgery. You didn't submit a fee for this information. You will find enclosed a check, which will help pay for your film and time.

After I reviewed your information about Gen. John Hunt Morgan, I went to the Civil War Special Section of the University of California, Santa Barbara Library. There I found a book entitled "History of Morgan's Cavalry". It was written by Basil Duke in 1867 and later published as part of the Centennial Series. It accounts a vivid portrayal of how Lebanon was burned and pillaged. You perhaps have this in your library.

Again I request that you check the Washington Co. Marriage Records 1792 -1826 for James E. Drury Book 5 #63.

Enclosed for your review is a summary of information on Royal Bowman. Please check out Casey-Lincoln Co. for information.

You previously sent me information about the Marriage records of Royal Bowman to Mary Riney with the Bond dated 3/4/1828, BK II page 88. Are there copies of these records? If there are, perhaps the parents are listed.

The information you sent on Roswell Bowman states that he was from Maryland. I do not believe that he is closely related to Royal Bowman, because records have stated that Royal Bowman and both his parents were from Virginia.

Royal Bowman was 78 yrs. in the 1880 census. He probably died before he was 85 yrs. Since he was so prominent would his death be mentioned in the newspaper? Are there cemetery records of him and his family?

I'm going to write to the persons with the Riney research.

Dear Ms. Glasscock,

Mary Jo Maguire of the Washington County Historical Society has been of help to me. She then referred me to a Gerald Thompson of St. Mary's KY, who I was told had information about the Bowman families and Catholic families in Marion, KY. I didn't receive a reply from him so I sought information from the Marion Historical Society. Through them, you notified me.

I have been informed that there are no records of Marion Co. before 1863. Knowing this, I realize that I need local help for possible information. Thank you for extending your help.

My great, great grandfather was Royal M. Bowman. I first located him in the Census of 1830 in Lebanon at #147, as Royal Bowman. (His wife was Mary A. Riney). I had known of these names from the death certificate of my great, grandmother Mary A. (Bowman) Moore, their second child and oldest daughter. One of her daughters was my grandmother, Lillie D. (Moore) Drury.

In the Census of 1850, he was located at #32,32 as R.M. Bowman with his wife Mary. His daughter, Mary A. (same name as her mother), and her husband Levi Moore were at #69,69.

Royal's son William M. Bowman, in 1910 verified the marriage of Levi Moore and his wife Mary A. (Bowman) Moore in the City of Lebanon, Marion County, Kentucky September 11, 1849. In a Mexican War pension application in 1907, Levi Moore had stated that he had been married in Lebanon, Marion County, Ky in a Catholic church by Father Quinn the same date, September 11, 1849 Are there records of this marriage? Levi Moore was born in Georgetown, Scott County, Ky. March 16, 1825. m.
Marie
I have not traced him into Scott County, as yet. I hope that if there is a marriage certificate his parents will be named.

In the Census of Marion County 1880, Royal and Mary A. Bowman and a few of the children are located at #311,354 on High St, Lebanon. If there are death certificates of members this family, perhaps the names of Royal's and Mary's parents will be recorded. It notes that Royal's father and mother were born in Virginia. The father of his wife, Mary A. Riney, was born in Kentucky and her mother in Maryland. Are there other records which could show the names of these parents? My review has shown that there were no Rineys in the Kentucky Census of 1790 but in the Census of 1810 there were 10 households with the name of Riney.

I have found in a typed copy of the records of the Marriage Ceremonies for Holy Mary Church, Calvary, Kentucky, 1807-1831 there is a listing on page 57 for Royal Borman and Mary Riney; March 6, 1828. I believe that this is for Royal Bowman. *yes Washington Co 3-4-1828*
Are there other records of this marriage?

Enclosed is a list of Mary Rineys from the records of Marriages Washington Co. 1792- 1826. Could the 1828 record be with these records? *NO*

The Bowmans and Rineys are the grand parents of my grandmother Lillie D. (Moore)Drury. Her husband and my grandfather, Eugene Edwin Drury, was born in South Carrollton, Muhlenberg County. His father Henry Drury and mother Miley Jane (maiden name not known but could be Walston) bought land in Muhlenberg County in 1839 for \$300.00. It was written that Henry was "late of Marion County". So, I believe that they were married in Marion Ky, about 1838.. Their oldest daughter Delphinia was recorded in her daughter's marriage record to have been born in Marion Co. (October 8, 1839).

In the Census of 1850 of Muhlenberg Co., Henry is listed as 35 yrs. (born about 1815) and Miley Jane as 26 yrs. (born @1824). When she bought land in 1856 in Muhlenberg CO. she was Miley Jane but when she bought land in 1864 she was Milly Jane.

Mary Jo Maguire found a Henry Drury born about 1819, baptized May 17 1819 the son of John Drury. This is probably another Henry Drury. She could not find a record of marriage for Henry and Miley Jane. Henry Drury would have been born in Washington County (birth date @1815).

In 1856, in Muhlenberg County, Miley Jane (from Marion County) was left \$900 in the will of William Walston (from Marion County). In the Census of 1830 at #152 I found that Obadiah and William Walston had females 5-10 yrs. Miley Jane would have been 7 yrs. old. However, these Walstons were born in Virginia. In the Census of 1880 Miley Jane claimed that both her parents were born in Kentucky. According to my records her first child was born October 8, 1839, when she was 16 yrs. So, she was married when she was 15-16 yrs. Perhaps she only guessed at the birth place of her parents. Are there records for the names of the Walston children in 1830?

The Census of 1840 for William Walston shows no female 10-15 yrs or 15-20 yrs. the ages that the female 5-10 yrs. in the Census of 1830 would have been in 1840. Miley Jane was 7 yrs in 1830 and 17 yrs 1840. Could this missing female be Miley?

In a will of James Gribbin written in 1831 and probated 1832, Witnesses were Joseph Walston Jr., Millie Jane Walston and Joseph Walston Sr. My Millie (Miley) Jane was only @ 9yrs. so couldn't have been a witness. [Joseph Walston Jr.'s wife's name was Jane.]

William Walston died Dec. 11, 1852 at the age of 66 yrs. in High Grove of dropsy. In 1856 Miley Jane (Walston?) Drury was left \$900.00 in his will. Administrators were Albin and Anthony who were his sons. Can you locate any records for this will and estate? If not, I can only guess that Miley Jane was a daughter of William Walston. It was interesting to find that the Drurys, Moores, and Bowmans and Walstons were in Washington, later Marion County at the same time.

In the Census of 1830 of Washington County: Henry Drury was @ 15 yrs. Miley Jane (Walston?) Drury @ 7 yrs.

125 William Drury: with 1 male 10-15 yrs. & 2 males 15-20 yrs.

147 Royal Bowman: [My Great grandmother Mary A. (Bowman) Moore wasn't born until 1832].

169 Joseph Walston Jr. 1 female 0-5 yrs.

152 William Walston: 1 female 5-10 yrs.

152 Obadiah Walston: 1 female 5-10 yrs.

157 Zachariah Drury: 2 males 10-15 yrs, 1 male 15-20 yrs.

203 John Drury: 1 male 10-15 yrs.

204 Joseph Walston Sr.: probably the father of William, Obadiah, and Joseph Jr. They were also in the Census of 1820 at # 384.

It is because of this close proximity of these families that I believe there is a good possibility that they are the families of Henry & Miley Jane (Walston?)Drury.

In 1865 William G. Walston the grandson of William Walston and whose father was Albany Walston married Mary Jane Drury the daughter of Miley Jane (Walston?)Drury. If I can definitely prove that Miley Jane Drury was the daughter of William Walston, they married first cousins. They had no children!! Albany was the executor of the will that gave Miley Jane \$900.00 in 1865.

I am Roman Catholic, as was my father. My grandfather was also, but might have been converted after marriage to Lillie D. Moore. They were first married by a Minister of the Gospel and one year later by a Catholic priest. Lillie D. (Moore)Drury's parents Levi and Mary A. (Bowman) Moore are buried at St. Alphonsus cemetery in St. Joseph, Daviess County, KY., and were married by Father Quin in a Catholic Church Marion County September 11,,1849.

As noted, I believe that Royal Bowman married Mary A. (Riney) at Holy Mary Church, Calvary, Ky. March 6, 1828. I don't know if both were Catholics. Levi and Mary A. (Bowman) Moore were married in Catholic church by Father Quin.

I contacted the Archdiocese of Louisville with my information; they referred me to Holy Name of Mary Church, Calvary, KY. They had no information about the Levi Moore or the Royal Bowman marriages, so they referred me to the Loretto Archives, Nerinx, KY. Once again, I was informed about the marriage of Royal Borman and Mary Riney, March 6, 1828. (I have seen this record. It is typed, so I believe that there was a mistake with Borman typed rather than Bownam.) They had no record of Levi Moore & Mary Riney.

They also again found the baptism of a Henry Drury who was baptized May 16, 1819, with father John and mother Theresa. My Henry Drury was 35 yrs in 1850. So, he would have been born in 1815. I doubt that parents would delay a baptism for four yrs., so this is probably the wrong Henry Drury. In the Census of 1830 at # 203 there is a John Drury with a son 10-15 year.

My great grandfather Eugene Edwin Drury's sister, Mary Jane Drury was married to William G. Walston by a Minister of the Gospel. So I believe that possibly the Drurys of Marion or Washington County were not Catholics. I don't know the religion of the Walstons.

My grandfather Eugene Edwin is buried in Mater Dolorosa Cemetery Owensboro, KY and my grandmother Lillie D. (Moore) Drury is buried in Holy Cross Cemetery near San Francisco, CA. They were married in 1879 by a Minister of the Gospel and again in 1880 in the Catholic Church, both in Daviess CO.

In the 1850 Census, William is 63 yrs. and Joseph is 48 yrs.
Joseph was a witness to the will in 1832, with Joseph Walston Sr.
and Millie Jane Walston. This Joseph would have been 30 yrs. in
1832, so he was the Joseph Jr. at the time of the will. Miley
Jane (Drury) was his cousin, aged 6 yrs.

William and Joseph Jr. were both born in Virginia as of the Census
of 1850. So Obadiah probably was also. Joseph Sr. and Sarah were
probably married in Virginia. But Miley Jane Drury was born in
Kentucky. In 1880 census she claimed that her mother and father
were born in Kentucky!!!! So whose daughter is she?
She was 14-15 yrs old when she married, so perhaps she guessed
at the birth place of her parents.

William Walston Sr.'s wife was Mary born in Virginia. In 1830 he had a son 10-15 yrs, so he was probably married about 1815-1820. He said to have been born in Brickhanon, Virginia.

Obadiah Walston's wife was?????

In 1830 he had a son 15- 20 yrs. so he was married 1809-1819, probably in Virginia. An "Obadiah" who was 47 yrs in 1870 was probably the son of Obadiah who had two sons 5-10 yrs in 1830. This "Obadiah" claimed that his father and mother, were born in Buckingham County, Virginia.

In 1832 Joseph Walston, Milly Jane Walston and Joseph Walston Jr. were witnesses for a will of James Gibbin in Washington County. Who was Milly Jane Walston? The wife of Joseph Walston Jr. whose name was Jane? Joseph Sr's wife's name was Sarah.

The only Drury listed was Zachariah in the Census of Marion County 1840 and the Tax Rolls of 1835 & 1838-39. He had 210 acres and value of \$100 in 1835 and 810 acres, value \$440 in 1838-39. Zachariah had two sons 10-15yrs in 1830.

The William Drury #125 and John Drury # 203 of the Census of 1830 are not in this census or these tax rolls. Have they left Marion County?? William had a son 10-15 yrs. and two sons 15-20 yrs; John had a son 10-15yrs in 1830. [Henry Drury would have been @15 yrs.]

This article appeared in the Lebanon Enterprise in 1964 or 65.

Another of Lebanon's historic old houses is the home of Mr. and Mrs. Walter Beswick, at the northeast corner of Main and Harrison streets. The fanlight with leaded panes over the door front is a showpiece. Royal Bowman, who constructed many Marion County homes of the era built this one in 1828 for his own use, and he built it to last. Even the inside walls are solid brick. Bowman had three sons in the Southern army but, even so, this house barely escaped destruction when John H. Morgan on his second visit here, July 5, 1863, burnt the town. Only the timely arriving of one of the Bowmans sons saved it, for the torch already had been applied. The place has long been known as the Edelen house, for it was purchased by Mrs. Beswick's grandfather J. H. Edelen a druggist, about 90 years ago. All the downstairs woodwork is hand carved, a different design in each room. The stairway is of ash, with cherry rail, and upstairs the original floors of ash and poplar still in use. Indoor locks are quaint and doorknobs are polished brass. door and window jambs are pegged. A Civil War memento, not connected with the house but cherished in the family is an old axe head used by Morgan to hack his way into the Edelen drug store that awful day in 1863, and found just outside the building the day after.

Unfortunately, shortly after this article appeared, the house was torn down and replaced with our new library. While we greatly needed a new library and certainly enjoy the benefits, our shortsightedness plagues us now.

"The house, named for the myrtle trees surrounding it, is full of memories. It is a cornucopia of Victoriana; each room is a treasure trove. On the first floor, the drawing room, music room, and formal dining room are filled with splendid antiques. A magnificent grand piano, of Wagnerian dimensions, dominates the music room. An eclectic assortment of 19th century furniture, extravagant in texture and fabric, can be found in the drawing and dining rooms and upstairs in the three bedrooms available to the public. Homemade quilts, antique dolls, period paintings and prints, dresser sets, lamps and a profusion of accent pieces complement the collection.

"There are wonderful and rare touches that invite visitors to step back in time. The elegant green-and-white wallpaper in the formal dining room, depicting a pastoral scene, was obviously custom-made, probably in Europe sometime around the turn of the century. Some of the flowered patterns of wallpaper in the sunny bedrooms date back to the same time. There are vintage Venetian blinds, in addition to elaborate drapery, on the windows throughout the house. One of the many chandeliers was custom-made in Venice for Brewer's grandparents while they were vacationing in Europe. A floral needlepoint rug in the drawing room was made by Brewer's great-grandmother.


"According to local legend, confederate Gen. John Hunt Morgan rode his horse up the main stairway, elaborate millwork be damned. Near the staircase, concealed under a rug, is a trapdoor, used during the Civil War to conceal a hiding place. And there is also a secret stairway nearby, behind a built-in bookcase that pulls out. The state has declared the house a historical landmark...

"...All of the antique-laden bedrooms at Myrtledene are spacious, with the characteristic lofty ceilings and huge windows that fill the house with light. The beds have that old-fashioned featherbed height but are graced with first-rate mattresses. There are two modernized bathrooms, side by side, in the upstairs hallway. The Bowman-Edelen-Beswick House. (Now destroyed.)

Dates from 1828.- Another of Lebanon's historic old houses is the home of Mr. & Mrs. W.E. Beswick, at the northeast corner of Main & Harrison Sts. The fanlight with leaded panes over the front door is a showpiece.

Royal Bowman, who constructed many Marion County homes of the era, built this one in 1828 for his own use, and he built it to last. Even the inside walls are solid brick. Bowman had three sons in the Southern army, but, even so, this house barely escaped destruction when Gen. John Hunt Morgan, on his second visit here, July 5, 1863, burnt the town. Only the timely arrival of one of the Bowman sons saved it, for the torch had already been applied. The place has long been known as the Edelen house, for it was purchased by Mrs. Beswick's grandfather, J.H. Edelen, a local druggist, about ninety years ago. All the doorways and doorways are hand carved, a different design in each room. The staircase woodwork is hand carved, and upstairs the original floors of ash and pine are still in use. Indoor locks are quaint and doorknobs are polished brass. Door and window jambs are pegged. A Civil War memento, not connected with the house but cherished by the family, is an old axe head used by General Morgan to hack his way into the Edelen drug store on that awful day in 1863, a day found just outside the building the day after.

The information you have gathered about Royal Bowman and family is more than I had ever hoped to obtain. Thank you for being so diligent. Thanks for naming me as a reference but I some of the information I gave you needs correction. You found that George Bowman was in Co. D 2nd KY. Cav CSA. So my reference was incorrect. The husband of Eleanor is Basil Riney. Zachariah Riney was his brother, so he was the uncle (not cousin) of Mary Alethea(Ann) Riney Bowman and the great uncle of Mary Ann Bowman Moore. Refer to new dates

Enclosed copies of information for the Eleanor Spalding Riney's family, the Thomas & Basil Riney families, the Royal Bowman family, which has direct lineage to me. After I found that George Bowman married Ada Sutton I found in the baptismal information you sent, George Bowman and Ada Smith parents: Julius Virgil Bowman Born Nov. 29, 1896 bap. Dec. 19, 1896, sponsor-Maria Sutton. Also, George Bowman & Ada Sutton parents: Mary Elizabeth Bowman born Sept 13, 1898, bap. Sept 13, 1898. Sponsor: Maria Sutton.


Mary Ann Bowman Moore's birth date is 12/18/32 as found on the grave at St Alphonsus cemetery and the death certificate. You have the grave date of George as 1844. But the at census August 1850 he was 7 yrs. and the census 1860 he was 17 yrs. The Spalding info: Jan 6, 1844. So I'm using 1844. Sallie Bowman birth was Sept 30, 1844 and baptized January 12, 1845. The grave says 1845. I'm using 1844 even though this is but nine months after George. What do you think?

You state that Royal conveyed the brick shop, May 1862 & Morgan's first raid on Lebanon was July 10, 1862. I believe that Lebanon was under the Union army control at this time. Since Royal was sympathetic to the Confederacy and was born in Virginia, it would seem he was forced out of business and given a low price for his property.

Eleanor Spalding Riney had a brother Richard Spalding (refer to info. copy.) His fourth child was Leonard Augustine Spalding b. Aug. 24, 1806. So he would be a first cousin to Mary Alethea(Ann) Riney Bowman. Leonard's father "was very rich and educated his children expensively" [Clements-Spalding and Allied Families pg 62.] "He (Leonard) died in Lebanon and left issue." It would seem that perhaps Leonard was a lawyer who was the trustee for the Bowmans and was authorized to sell his property. He died Feb. 28, 1888. His father, Richard, "was a discounter of notes of his less prosperous neighbors oppropriously called 'shaving' and then thought to be very sinful" Leonard could have been in the same business. However, it seems helped his cousin regain her house.

Can you obtain five copies of the Montage? I will send them to my children.. Enclosed, a check for your time and postage. Mrs. Thompson sent me a copy of the Video "Maryland Pioneers at Home in Kentucky" from which I have been able to feel closer to my father's kinfolk. Last week I've requested info from Casey Co. about Winston Bowman, who was in the Legislature in the 1840s. Are you certain that William was my Royal's father? I hope that info about Winston might clarify this family. Hope your winter is less severe this year. Happy Thanksgiving, etc.

42 Benedict⁴ (BENEDICT³, William², Thomas¹) was the oldest son of BENEDICT and ELIZABETH (MATTINGLY) SPALDING. He was born after 1746 for when he was excused from military duty from the fourth regiment of the Kentucky Militia on Oct. 15, 1791 he did not claim exemption for being over the age limit which was forty-five years, but for a physical disability. However, in the of Dec. 22, 1791, we find the following BENEDICT SPALDING by Captain Muldraugh's information is exempted from military duty Dec. 22, 1791. Since Muldraugh's information exempted him permanently, I think he must have reached the age limit of forty-five at this time, which would make his birth in Dec. 1746. Since he was co-administrator with his mother of his father's estate, I judge he was the eldest son.

He married ALETHAIRE ABELL, daughter of Samuel and Eleanor (Bryant) Abell about 1770. He left Calvert County with his mother on the death of his father, returning to St. Marys County, and married like her, within the year. He was a planter and became prosperous, for the census of 1790 shows him to have twelve white dependents and ten slaves.

The records do not show what became of the two hundred acres of "Hearts Delight" which his father owned at the time of the latter's death. I suppose he and mother disposed of it and bought other land, for on March 29, 1791, John Ford and Benedict Spalding deeded to Elias Smith one hundred and seventy-five and one eighth acres part of "St. Giles", "Nay Polé" and "Primus" shown by a clerk's minutes, records being destroyed. The sale of this land would seem to fix the time at which Benedict immigrated to Kentucky. Some authorities claim that he came to Kentucky in the fall of 1790 while others say he came out in the spring of 1791. Arch-Bishop MARTIN JOHN SPALDING agrees with the latter statement, in a letter he wrote to C.E. Spalding who was collecting data for the Spalding Memorial. On June 21, 1859, I find that he with Elias Smith appeared in the St. Marys County Court to prove the will of Priscilla Mattingly Dec. 14, 1790. So it seems certain he brought his family to Kentucky in the spring of 1791. He settled on the Rolling Fork near where the little town of Calvary now stands. The Washington County, Kentucky Tax List of 1792, shows him taxed with seven slaves, four horses, three cattle and four hundred and forty-four and one half acres of land. On August 9, 1797 he bought from James Cloyd of Lincoln County, six hundred and seventy acres lying on both sides of the Rolling Fork (Book B page 76) and built his home on the south side of that stream opposite the site where the Calvary Church and Convent afterward stood, on part of said land, ninety-five acres of which he sold to Rev. M.J.C. Fournier in 1797 for fifty-seven pounds (Deed Book B page 12 Washington County.) He bought one thousand and two hundred and sixty acres at a tax sale from Sam Grundy, Sheriff, Sept. 25, 1798. (Book B, page 622 Washington County, Ky.) However, about four hundred acres of this land was to go to other relatives parties, as prearranged.

Wealthy, intelligent, highly respected, he was soon prominent in affairs of his adopted county, was Justice of Peace (Deed Book 1, page 467). Represented Washington County in Legislature (WesternWorld Frankfort, Ky. Aug. 16, 1805). Was sheriff of Washington County in 1809 (Suit Benedict Spalding against R&Z. Forrest Aug. Court 1809, no. 76). BENEDICT does not seem to have taken a very active part in the Revolutionary War. He was in the St. Marys County Militia, in 1780. (Maryland Historical Society page 243) He did some other service for the cause for I find an order to the West Shore Treasure to pay Benedict Spalding eight pounds and fourteen shillings. (Md. Archives Vol 48. p. 25)

Dear Dr. Drury,

I have begun to collect Bowman information for you but there is more that I have not reviewed. However, I have a consulting job in New Mexico and won't be able to work on your information again until after May 15th. I send you what I have, because if you are like me you are anxious to learn all that you can about your ancestors.

You didn't mention it and I wondered if you knew that Royal Bowman was considered a master builder. Master builders in the early and mid 1800's would be like architects today. He built a number of houses in Lebanon and several of them are still standing. I believe I have some photographs of some of the homes. If I do, you want me to make copies of them for you?

Mary A. Riney is the daughter of Eleanor and Basil Riney. In the will of Benedict Spalding, he mentions his daughter Eleanor Riney. Also on her marriage license it lists Eleanor Riney as her mother. Basil Riney is probably the son of Thomas Riney. Thomas lists his children in his will and I believe Batsel is a typing or transcription error for Basil.

Royal Bowman is probably the son of Thomas and Catherine Bowman but I have not been able to locate any proof of this. There is a Boarman/Bowman Book in our library but it mentions a Royal Bowman as belonging to another line that was not research for this book. There was no information in the Riney, Bowman, Drury, Walston, Gribbins family files that helped. Most just contained requests with little or no attached information.

I am really struggling with the Walston/Gribbins/Drury lines with no information to date.

I went through the baptisms records at St. Augustine Church, Lebanon, Kentucky. I copied all the Bowmans and Moores that were Royal's children, grandchildren and may have picked up some great grandchildren. Looks like I have some different dates of births and some different names.

of him in Tenn. he married three times and was left without an heir. He had grown very rich, his third wife died and he had no company but his negroes, of course he was lonesome, on seeing my father after he was grown up insisted he should visit him and promised him a negro for his visit accordingly my father visited him, he said his uncle had all a man need to want, a negro, any amount of broad acres, a cellar of the best drinks, money and stock a plenty. When father reached his place, uncle Sam at once made preparations for a good time that night after supper, he ordered in twelve, ten year old negro boys, good dancers, after the old Virginia style and good fiddle the bowl was kept full and the dance continued till ten o'clock. Then the negroes were sent to their quarters. Then Mr. Sam tolerably full commenced a conversation in which he gave a history of his life and detailed account of his three wives and dwelled long on his troubles, part of which ran about as follows, "Well I how te Lord, pen goot to me. I haf cot eferysting & neant more, even I married my first wife

Ky. river at a ford or shoal, one mile below
Brown was drowned. He is buried there
just above the high water mark. He left
his wife and three children, William, Jacob,
and Elizabeth. His wife took her children
and joined what is known as the Shaker
Family, located near Harrodsburgh,
Mercer county Ky. and staid for a time.
She became dissatisfied and left the Shakers
then bound her two boys out to a very

My Greatgrandfather died just before the
Revolutionary war. My father, John Bow-
man was born in Penn, in 1780. There
were also two other brothers, Joseph and En-
och and one sister Nancy, older than
they. Joseph was killed by the kick of
horse before he was grown. In 1790 my
grandfather, Enoch Bowman with two of
his brothers, Joseph and Samuel removed from
Penn and settled in East Penn, then part
of Virginia and located five miles west
of where Jonesburgh now is, the county seat
of Washington County and there, built a
grist mill. After some years, probably about the
time my father was grown. My grandfa-
ther undertook to clean his millrace, after the
water was drawn off; but being subject to
epilepsy, had a spell while cleaning it and

fell in at Cordanks and married his daughter ^{our name} Rachel, these were my grandfather and Grand mother. They settled and remained in South Carolina till my mother was ten years old, the youngest child. Then removed to Tenn and settled in Jefferson county, one mile southeast of Bulls Gap, in Bay's mountains. The country was new and land cheap, so in a short time he owned 320 acres of excellent land. He had four sons, Stephen Thomas, Wallace and James and three daughters, Sally, Martha & Mary. Stephen was sickly and died before grown. Thomas and Wallace volunteered in the U.S. Army in the late British war, at the same time my father did. They took the measles before they started to the front, the regiment started when the measles was raging the highest, the second day out they had to cross a river without a ferry; being infantry they waded waist deep and died on the opposite bank. Martha the oldest living daughter married a Josiah Daugherty and in about 1835 moved to Missouri, settled in Springfield and there lived and died. Their oldest son I knew as Mat about my age is all I knew of their children.

Dear Ms. Glasscock,

Thank you for all the wonderful information you sent me. You gave me information about my grandmother, so that I now know her baptismal name of Dafrosia and that the baptism took place 6 years and 5 months after her birth March 26, 1860. Her brother was baptized the same day, 8 years after his birth, July 23, 1858. This is why I failed in my search of Louisville files. I guess the parents wanted them to be baptized in the same church as their siblings. Do you know anything about the name Dafrosia?

Mary Jo Maquire informed me that there were Walstons and Drurys in the records of Holy Name of Mary Church at Calvary (Marion Co.) Ky. There was a baptismal record of a Henry Drury May 17, 1819. Birth @1819. Father John. My Henry was born in 1815.

In the Census of 1830 Washington Co. page # 125 there is a William Drury & family with a son 10-15 yrs, and 2 sons 15-20 years. My great grandfather would have been 15 yrs. My great grandfather's oldest son was William H. Drury. He could have been named after his grandfather William and his father Henry, so his name was William Henry. Or perhaps my great grandfather's name was William Henry and he was called Henry. So, while searching please consider William Henry Drury as well Henry Drury.

The dates you supplied easily replaced the dates approximated from census records. Enclosed corrected Bowman and Moore records for the Historical Files.

In the Census of 1820 #344 I interpreted a Bittel Riney. Did I misread this name? Is this Basel? If this is please send me a copy.

Please check in the Washington Co. Marriage Records 1792-1826 for James E. Drury Book 5 #63. This could be the brother of Henry Drury because his second son was James E. Drury. It's worth a try!

In my letter of May 13, 1995 I forgot to tell you that I would like copies of the photographs of the homes that Royal Bowman built. I believe that his son James A. Bowman, born in 1830, was a physician. Do you have records which verify this?

With your lead naming Basil Riney as the father of Mary A. Riney Bowman, I reviewed my files and found that in the Washington Co Census of 1810 there is a listing for only one Bazil Riney, one Thomas Riney, and one Zachariah Riney.

Bazil Riney: three male 0-10, one male 16-26, one male 26-45. one female 0-10, two females 10-16, one female 45+.

Mary A. Riney Bowman would have been @3 yrs. (born @1807).

Thomas Riney: two males 16-26, one male 26-45, one male 45+. one female 10-16, one female 45+.

This could be the Thomas Riney who wrote the will in 1795 or his grandson. Or is the will only recorded at the time of death?

Zachariah Riney: eight children, one male 45+ and two females 45+. He is probably the brother of Basil (Batsel) (Bazil).

Also listed in the 1810 Census. (Henry Drury not born until @1815
35yrs.Census 1850).

Is this where the marriage certificate would be located even
though the marriage was in 1828? In the Census of 1830 Royal
Bowman was 20<30 yrs as was his wife Mary (Riney). There was one
male under 5 yrs. There was one slave 10<24 yrs. They were
married in a Roman Catholic Church March 6, 1828. We know that he
was born in Virginia and she in Kentucky.

My greatgrand mother Mary Ann Bowman Moore, their daughter, was
born December 19, 1832. She married Levi Moore September 11,
1849. In the Census 1850 Levi and she were at #69 on August 26,
1850. Her father R.M. Bowman was at #32 on August 24, 1850

CENSUS MARION CO. 1840

Miley Jane (Drury) would be 16 years old since she was 26 years old in the Census 1850. Her oldest daughter was born on Oct 8, 1839, so she was married about 1838 when she was 14-15 yrs old. She and Henry were not living with the Walstons in 1840.

Albin Walston: 1 male <5 yrs., 1 male 20<30 yrs., 1 fem. 20<30 yrs. father of William G. Walston. Son of William Walston.

Richard Walston: 1 male <5 yrs., 1 male 30 <40 yrs., 1 fem. 10<15 years., 1 fem. 20< 30 yrs. [this name not identified]. He could be a son of Obadiah. He had a son 15-20 yrs.in 1830.

William Walston: 2 males <5 yrs., 1 male 5<10 yrs., 1 male 20<30 yrs., 2 fem. 30<40 yrs., 1 fem. 40<50 yrs. This could be a son of Obadiah since he had a son 15-20 yrs, and two sons 10-15 yrs; or William a son 10-15 yrs in 1830.

William Walston Sr.: 1 male <5 yrs., 1 male 5<10 yrs., 1 male 10< 15 yrs., 1 male 50<60 yrs., 1 fem. 5<10 yrs., 1 fem. 50<60 yrs. [no female 15-20 yrs.] [had 1 female 5-10 yrs in 1830].

Joseph Walston (Jr?). Pg 27 #4 : 1 male 10-15 yrs., 1 male 30-40 yrs., 1 male 80-90 yrs. 2 females 0-5 yrs, 2 females 5-10 yrs, 1 female 30-40 yrs, 1 female 70-80 yrs. The older people were probably living with two parents and their children, since in the Tax rolls of 1835 & 1839 Joseph Sr. had no land but had 1-2 slaves. This was probably Joseph Sr. and wife Sarah.

Obadiah Walston: 1 male 10-15 yrs., 1 male 15-12 yrs, 2 males 20-30 yrs., 1 male 50-60 yrs, 1 female 50- 60 yrs.[no female 15-20 yrs.]

[had 1 female 5-10 yrs in 1830.] Therefore, Miley Jane could have been a daughter of William or Obadiah Walston because the daughter 5-10 yrs in 1830 is not listed in 1840. Most likely, William was the father.

Consider: the two girls absent in this census might have died rather have been Miley Jane.

I realize that this is a great amount of information but I hope it will be of help, so that you don't have to repeat and waste your time and effort in your research. Would cemetery records be of help?

I need:

The birth dates and parents of Henry Drury and Miley (Milly) Jane (Walston??)

Their marriage records, which would be about 1837-39 in Marion or Washington County.

The marriage certificate of Royal Bowman to Mary A. Riney Listed as March 6 1828 page 57 Marriage Ceremonies Holy Mary Church Calvary, KY.

The parents of Royal Bowman and Mary A. Riney.

The marriage certificate of Levi Moore to Mary A. Bowman September 11, 1849.

If William or Obadiah Walston had a daughter named Miley (Milly) Jane.

Check if there are local genealogical records of Drury, Riney, Bowman or Walston that members of these families might have started. Are there still descendants of these families living in Marion Co?

BOWMAN, ROYAL

Mary Ann Bowman, the wife of Levi Moore, was the daughter of Royal Bowman and Mary Alethea Riney who were m. at Holy Name of Mary Church, Calvary, Marion County, Kentucky, on March 6, 1828. Royal Bowman was b. in Virginia on November 18, 1802 and d. January 27, 1891. Mary Alethea Riney Bowman was b. in 1807 and d. June 8, 1893 in Kentucky. They were both buried in St. Augustine's Cemetery, Lebanon, Marion County, Kentucky.

Royal Bowman was a master builder and built several homes in Lebanon, Marion County, Kentucky. Most notable is Myrtledene, which was built in 1833 for Benedict Spalding III, his wife's granduncle, the brother of her grandmother Eleanor Spalding Riney. It was used by the Confederate General John Hunt Morgan during the occupation of Lebanon during the Civil War about 1863. It is now used as a Bed and Breakfast. Other homes built were the old Jackson House on East Main, the "Ma" Wathen place Southeast corner of Main and Forest, two other houses built across the street from the Wathen house; a house built in 1828 was torn down and replaced with the Library. His life's history was published in the *Montage of the Lebanon Enterprise, Fall 1996*. Royal Bowman and his wife Mary Alethea Riney Bowman had 12 children. Of these Royal Martin, Catherine Maria, Maria Catherine, Sarah Elizabeth, Robert Benjamin, and Leonard Monroe were baptized at St. Augustine Church, Lebanon, Kentucky from 1837-1852. Ben enlisted with General Morgan CSA at age 13 years, George was in Co. D. 2nd Kentucky Cav. CSA. William M. Bowman of Co. K 8 KY Cav. CSA was captured at Zanesville, Ohio during the Civil War. George, James A., "Prince" Royal Martin and Leonard Monroe were buried with their parents at St. Augustine Cemetery, Lebanon, Kentucky. Ben Bowman is buried in Danville, Kentucky.

Royal Bowman's parents were William Bowman (1770-1849) and Elizabeth Ann Wilkerson (1779-1849) who settled in Lincoln County before Casey County was founded in 1806. They were both born in Virginia. Their older children were Winston, William and Elizabeth Ann. Winston Bowman (1805-1892) was a judge in Casey County for forty years.

Royal Bowman's wife Mary Alethea Riney Bowman was the daughter of Basil Riney born after 1763, Maryland, and Eleanor Spalding Riney born 1775, Maryland. Basil Riney died 1824 in Hardin County, Kentucky and wife Eleanor died 1883 in Kentucky.

Eleanor Spalding Riney's parents were Benedict Spalding II who died August 1, 1815, buried in Holy Name of Mary Church Cemetery, Marion County, Kentucky, and Alethaire Abell, who died December 1, 1821, buried Marion County, Kentucky.

Homes Built by Royal Bowman


Located at the corner of East Main Street and Forrest Street, this brick home was built @ 1850's for W. W. Wathen by his father's brother in law, Royal Bowman. It was originally known as the "Rose Cottage."

The old Jackson house, located on east Main Street, was built for Thomas and Nancy Rodman Jackson. The house was built @ 1830's.

"Myrtledene" located on north Spalding Avenue was built in 1833 for Benedict and Elizabeth McElroy Spalding.


No longer standing, but located where the Marion County Public Library is, was the home of Royal Bowman. It was built before the Civil War and the last tenant was Walter Beswick.

This house built @ 1840 was built for David Phillips. Miss Edmonds' article indicated that Phillips probably built the house. Later Mr. Dehringer, wrote that the home was built by Royal Bowman. There are similiar features in this house, the house next door (see bottom photograph), the Jackson house and the house Royal Bowman lived in.




Approaching Lebanon from Springfield you will see, on your right, a spacious antebellum brick home, built in the early 1840s by Joseph Spalding. The wide central hall, entered by an arched front door, extends the full length of double parlors and has a beautiful cherry stairway. Chandeliers in the hall and parlor are reflected in floor-to-ceiling mirrors.

Mr. and Mrs. C. E. Willard purchased the property in 1933. Their daughter, Martha Jean, still lives in the old home place.



Colonial Myrtledene, which stands at the bend in the road on Spalding Avenue, was built in 1833 by local contractor Royal Bowman for Benedict Spalding II and his third wife, Elizabeth McElroy. Confederate General John Hunt Morgan made his headquarters here in July 1862. It is said that he rode his horse in the front door and started up the stairs, where his horse left hoof prints.


Current owner Lillian Brewer is a great niece of Elizabeth McElroy. The home is now a bed and breakfast and is operated by James Spragens.




The old colonial front house at 312 North Spalding Avenue was built prior to the Civil War. Mr. and Mrs. Orson Ames were living there in 1858 when their daughter Lena was born. The home was purchased in 1947 by Mr. and Mrs. Joe Hardesty, who added the wide front porch and tall columns. A more recent owner was Circuit Court Clerk Lois Fogle. Now it is the property of Stephen and Robin Humphress, who live there with their children.

A beautiful old Victorian mansion with its third-floor tower and cupola can be found at the corner of North Spalding Avenue and High Street. Built in 1878 by George D. Boldrick, a prominent druggist and distiller, it was later occupied by the R. N. Wathen and T. W. Abell families.

Lebanon Mayor Kathy Blandford lived in the house from 1972 until 1993, when the property was sold to Dr. Greg and Laura D'Angelo. It is now owned by Jimmy and Jane Higdon, who live there.



The two-story Victorian home at 335 North Spalding Avenue was built in the 1880s by W. C. Rogers, one-time president of the Marion National Bank. Stained glass doors and windows grace the entrance. Current owners Mr. and Mrs. Hugh C. Spalding purchased the home in 1946 from Mrs. Helen Rogers, whose husband was descended from the builder.



father had sons and daughters, Moses, John, Peter, William (my grandfather), Thomas, still living in Lee County; and Abigail, a widow now living in Montgomery County. My father was a worker in wood and iron. He made the first sorghum mill in these parts and caught the last wolf caught in these parts in 1870. There were eight young ones in Owsley County or on Ross' Creek, Lee County. Moses went to Tennessee, and John lived and died in Montgomery County and was a magistrate. All are long lived. My grandfather had 14 children. Four of them still live in Owsley and Lee counties. My grandfather helped to build the

first railroad car in Kentucky at Lexington where he lived at one time. His greatest work was making a thrashing machine, the first one ever used in this part of the state. He had never seen a machine but had, I suppose, read of them. He made iron journals. Being an artificer in both wood and iron, he could use both. It was not unlike the "ground hog." It was a success and was extensively used. I saw the machine work when I was a child. There were four levers, and he worked six horses. The master wheel was of wood. Locust cogs or pins were used. While he lived at Lexington, he made some machinery for President Polk, before he was President, for the manufacture of cotton yarn in Tennessee. He referred to the building of the first railroad car as the greatest achievement of his life. It must be remembered that the first railroad between Baltimore and Washington was in 1830, and the one between Lexington and Frankfort was in 1831, so that the cars were a new thing. He made this car according to his own plans, submitted by him. *The Lexington Observer* contained an account of this car given to Colonel Hodges by me in 1888 or 1889. He made many kinds of musical instruments.

We have a harp, an Italian harp now, of his make, played with two mallets, a three-cornered box. He was fond of hunting and fishing and had indulged his tastes freely. He died in February 1881 about 81 years old. He married a Margaret Bowman and had 11 children.


Bowman

My grandmother, Margaret Bowman, was the daughter of Jacob Bowman in Clay County who came to Clay when a boy with his father, Cornelius Bowman from Silver Creek, Madison County. James Moore, a son-in-law of Cornelius Bowman came to Owsley County in 1796, becoming the first settler of what is now Owsley County. He located on the opposite side of the river from the present site of Booneville on the farm now owned by S. B. Shepherd. Cornelius Bowman became a citizen of Owsley County

and bought lands for his children and afterwards returned to his lands in Madison County. His children were Jacob Cornelius, Elisha, Elijah, Thomas, John, Mrs. James Moore, and other daughters. Jacob married an Evans. He was my great-grandfather.

Powder Manufacture

He helped in the manufacture of gun powder near Mt. Sterling for the soldiers of the War of 1812. The salt-peter was gotten from the caves of the sub-carboniferous region. He was only 12 years old at the time. Both he and his wife had cholera in Lexington in 1832 and 1833. In the morning newspaper, he read of his own death but said, "I knew that it was not so." He was eccentric. His favorite books were the *Bible* and the *Works Of Dr. Thomas Dick*.

Widely-Respected Mercer County Couple Were Wed In 1842

Golden Wedding Anniversary United Descendants Of Pioneers Of A Century Earlier

Author Unknown - 1892

Mr. Dudley Mitchem Bowman and Mrs. Virginia Smith Bowman, of Mercer County, Kentucky, celebrated their golden wedding anniversary on Thursday, September 29, 1892, at their home, "Bellevue," near Bur- gini. From the Danville correspondent of *The Louisville Times*, the following is extracted:

"September 29, 1842, a large and fashionable assemblage met at Avondale, in Mercer County, the home of Abram Smith, Esq., to witness the marriage of his daughter, Virginia, then in her 17th year, to Dudley Mitchem Bowman, the son of a neighbor, the Hon. John Bowman. Avondale was then, as it is now, a lovely country home, where a bounteous, graceful hospitality was dispensed, and it is interesting to know that it yet remains in the family and is no less celebrated for perpetuating its old-time reputation.

"The ceremony of 50 years ago [1842] was spoken by the Rev. Thomas Smith, one of the pioneers in the Campbell and Stone's reformation, then just beginning. The bridesmaids were Miss Peachy Smith, now Mrs. Simeon Drake, of Chicago, and Miss Johanna Smith, a sister of the bride, who married Mr. McCann. The groomsmen were Abram Hite Bowman, brother to the groom, and Ben Campbell, yet living in Mercer County. The marriage united two of the most widely-known and respected families of Kentucky, whose names are associated with the early conquest of the land and identified with its erection into an independent state.

"In the colonial annals of Virginia are found their names in places of civil and military distinction. They came from the Shenandoah Valley in Virginia, and Zachariah Smith and Abram Bowman were among the first to make a new home in the wilderness of Kentucky; Smith at 'Ingle-side,' near Danville, Boyle County, and Bowman in Fayette County, only a few miles further away.

A few years thereafter the estate known as Bellevue came into the possession of John Bowman, father of the present owner, by bequest from an uncle. John Bowman was a man of more than ordinary culture for his time, a lawyer by education and a pupil of Henry Clay. His wife was Sarah Mitchem, of Woodford County, daughter of Dudley Mitchem from whom have come the Woolfolks, Haydens, Bannons, and other families well known in

Louisville, Lexington, and the Southwest. Their children were the late John Bryan Bowman, for many years Regent of Kentucky University; the late Abram Hite Bowman, many of whose descendants now live in Louisville and various parts of the state; and Dudley Mitchem Bowman, the present owner of Bellevue. It is a rarely beautiful old country home, nearly a century old and substantially built. The arched windows, picturesque fans over the doors, and beautiful hand-carved wooden mantels and window frames take one back to the architecture and house decorations of old Colonial days. The walls are covered with portraits of the former owners and occupants of the home. Mr. Bowman tells with justifiable pride that only Indians and Bowmans ever owned the place. It has been for a century the seat of a princely hospitality, and it was an interesting occasion, the celebration of a golden wedding, that brought under its roof the descendants of the pioneers of a

century ago.

"A notable feature of this delightful reunion was the singularly appropriate remarks of the Rev. Owsley Goodloe. Two conspicuous figures were Uncle Louis and Aunt Caroline, former slaves, whose marriage antedated that of Mr. and Mrs. Bowman by six years. At the wedding 50 years ago Uncle Louis had the distinction of driving the carriage and Aunt Lucy was maid in waiting to the bride.

"Owing to the death of a lovely daughter, Mrs. Caroline Bowman Ringo, the guests were limited to the family and a few intimate friends. Among those present were Mary Watters Bowman, widow of the eldest son; John Bryan and his son and daughter; Jennie Bowman Cassel and her two daughters; Dudley M. Dunlap, Jr., and wife, Mary; Nannie Bowman Moore and her five children; Abram Smith Bowman of Fairlawn, Lexington; Miss Nannie Smith; Mary D. Bowman; Mrs. John Augustus Williams; Phil B. Thompson; Rev. Strother Cook; Ben C. Allin and wife, who have been married nearly 65 years; Mr. and Mrs. W. H. Riker; Mr. and Mrs. Thomas Bowman; Rebecca Jones; Mr. and Mrs. James Kuninano; and Mr. and Mrs. William Rowland and Miss Vivian.

Mr. and Mrs. Bowman, though rapidly approaching that age which marks the evening of life, are yet hale and hearty, and give promise of being able to celebrate many more anniversaries of their marriage."

James married Elisabeth, and had, among others, Isham Talbot, born 1760, a Revolutionary soldier, who married his cousin Jane and had Dr. John M. Talbot, of Louisville, Kentucky, deceased; Sophia, who married Judge Peck of Tennessee; Elizabeth, married John Raine, Sr.; and Isham Talbot, Sr., married Elizabeth Davis and had, among other children, Isham Talbot, a Senator, and Jane.

Bowman

The pioneer Bowman family of Eastern Kentucky can be traced to ancestors who first settled in Madison County, and then spread into Estill, Clay, Breathitt, Owsley, Lee, and other counties around the state. The first of the family with definite information is John Bowman, born around 1725 in Virginia, and died in Madison County, Kentucky, 1800. He and his son, Cornelius Bowman, and their families moved from Virginia to Madison County and settled on Muddy Creek ca. 1790. Cor-

nelius Bowman, son of John Bowman, born 1740, in Virginia, died January 1, 1826 in Madison County, Kentucky, married Susanna Abbott (born in Virginia ca. 1742, died in Kentucky in 1802). Their children were (I.) Elijah Bowman, who married Elizabeth Gentry, in Madison County. Their children were: Henry Bowman, married Rachel Plummer; Elisha W. Bowman, married Evaline Isaacs; Ibby Bowman, married Valentine Crawford, of Lee County, Kentucky; Joseph Bowman, married Cynthia Crawford; Debbie Bowman, married John Brandenburg and lived in Lee County, Kentucky; and Thomas Bowman. (II.) Rev. Elisha W. Bowman, born in Virginia, December 25, 1775; died in Estill County, Kentucky, October 3, 1845. He was a celebrated Methodist preacher and capable physician. He was converted early in life and licensed to preach at the age of 16.

Miss Spalding, who was on the rear seat, was thrown with much force against the top of the car. One of the wooden ribs supporting the top struck her in the face, cutting a deep gash across her nose and badly bruising her right eye. The wounds were very painful and bled profusely. The machine was quickly stopped and Miss Spalding taken to a nearby house where her wounds were bathed and temporarily dressed. Arriving in town she was

driven at once to the hospital where medical attention was given her injuries. For several days following the accident her injuries were extremely painful. They are not, however, of a serious character, and are now rapidly mending.

YOUNG GIRL IS VICTIM
OF AN ATROCIOS ASSAULT.

Charged with an atrocious crime, John Boarman, Jr., and Clarence Alford were arrested Tuesday afternoon by Sheriff John A. Burton and placed in the county jail. The warrant, under which they were arrested, was sworn out before County Judge A. P. Carter by Minnie Doering, the 18-year old daughter of John Doering, who lives in the Simms' neighborhood, six miles northeast of Lebanon, and charges the two young men with rape.

The alleged crime was committed Sunday afternoon near the Sulphur Springs, a mile and a half southeast of town, and, it seems, was kept quiet by those who knew of it until after the men had been placed under arrest. Even then few were aware of it, and not until Wednesday morning did the news spread to any considerable extent. Since that time a great deal of indignation has been expressed, and some talk of mob violence has been heard. Wishing to take every precaution to protect the men, Judge Carter Tuesday night had the jail guarded to thwart any attempt that might be made to lynch the men. The examining trial was set for yesterday, but the prisoners waived examination and were remanded to jail without bond to await the action of the April grand jury.

The pitiful story told by the girl, and which, in part, is corroborated by three well known young men of this city, places the crime among the most brutal that have occurred in the county in years. The girl lives with her parents near Simms, and enjoys an excellent reputation among those who know her.

According to her story she was visiting her sister, Mrs. John Carrico, who lives with her husband on the farm of R. N. Wathen, on the Danyville Pike just outside the city limits, and had been there only since Saturday. Sunday afternoon Boarman, whom she said she had known but a short while, drove to the Carrico home about five o'clock and asked her to go riding with him. She told him, she said, that it was too late, but when he said they would drive only a short distance out the road and would soon return she consented. Boarman drove to the Sulphur Springs. There they were joined by Alford, who had earlier in the afternoon been seen with Boarman driving about town, and who had by arrangement, it is said, walked to the springs to meet Boarman. The girl said she begged the two men not to harm her, and to take her home, but that they paid no attention to her entreaties. She said she was made to drink whiskey and that they threatened her life, but that notwithstanding this fact she resisted them until she had been cruelly beaten and her strength was entirely exhausted. She was then shockingly mistreated by the men. Boarman later brought her home, she said, and told her he would kill her if she should ever divulge what had happened.

Upon her arrival she at once told her sister of what had taken place. Her clothing was partly torn from her, and her waist was beaten with blood. She exhibited a number of wounds as evidence of the frightful ordeal through which she had passed.

Monday the girl, accompanied by her sister, went to the office of Judge Carter where she recited her story and asked for a warrant for the arrest of Boarman and Alford. When asked if she had evidence of any kind to corroborate her story she said that three young men came to the springs while they were there, but that she did not know any of them. They remained but a short while and left. She said that

The three young men had been at the springs but a short while until Alford, whom they had passed walking along the road, arrived. He passed the buggy, speaking to the occupants as he did so, and sat down at the spring-house. The young men say that while they were at the springs the girl got out of the buggy; that she begged to be taken home and that it was apparent she had been crying.

The Deering girl is the daughter of humble parents, but is given an excellent name by prominent citizens who know her.

Boarman was involved in a similar trouble a year or so ago when he was indicted at the instance of a girl who alleged that he had mistreated her while returning from a dance near New Market. He was tried twice, but each time the jury failed to agree upon a verdict and he finally secured a dismissal.

A TIMELY SUGGESTION.


Editors of THE ENTERPRISE:

CUTTING CORN FOR SILAGE.

The composition of corn undergoes rapid changes from the tasseling period until maturity. The dry matter shows an increase of tons per acre from the time the corn is in tassel until the kernels are dent. Teased corn has only one-fifth as much dry matter as mature corn. It is owing to such changes that corn must be cut at the proper stage if it is to make the best silage. If cut too green, the silage will sour more easily, and will not possess the fullest food value. Immature corn is often the cause of the complaints that silage makes undesirable milk. Cut too ripe, the desired succulence is lost. The proper stage for cutting is when the lower leaves have commenced to fire and brown, yet when the greater part of the leaf is still green. The kernels should be out of the milk stage and dentated and hardened.

LICENSE TOO HIGH.

Five thousand dollars a year is too much for a saloon license in Bowling Green, the Court of Appeals decided recently in affirming the Warren Circuit Court in the case of Townsend, Mayor against John Gorin and same against Montgomery & Williams. The Court of Appeals holds that the license, fee is unreasonable and intended to defeat a statute. When Warren county took up the question of saloons the city of Bowling Green voted wet, but the city council met and fixed the saloon license at \$5,000. Saloon-men brought suit to compel the council to grant licenses and the lower court granted a writ of mandamus against the council requiring it to issue licenses under the old law. The lower court is sustained by the higher court.

Honest in his actions and upright in his dealings with men, he enjoyed the confidence and merited the good will of all who knew him. Mindful of the uncertainties of life and ever practicing the duties belonging to his station, he was a God-fearing, Christian, charitable man, giving to the poor and ever ready to lend a helping hand to those in distress. Many friends and acquaintances extend sympathy to the sorrowful family in their great bereavement.

DEATH CLAIMS MRS. YOWELL.

Mrs. Mattie Lue Yowell, wife of J. Q. Yowell who lives above Bradfordsville, died at her home on Thursday morning, October 19, 1911, after an illness of several years duration. Mrs. Yowell was about 48 years of age at the time of death. Funeral services were held Saturday morning at Pleasant Valley church, conducted by Rev. Joseph Montgomery, and the interment was at Old Liberty burying ground. She is survived by her husband and two daughters, Mrs. Mary Swiggett and Mrs. Estell Adams, both of whom live in this county; also by one brother, two sisters and one half brother.

NEW TRIAL DENIED BOARMAN.

Circuit Judge J. H. Thurman on Saturday, the last day of the recent session of court, overruled a motion for a new trial in the case of the Commonwealth against John Boarman, convicted and sentenced to die for assaulting Minnie Lamb, a 17-year old girl residing in the extreme northeastern part of the county, last February. At one o'clock in the afternoon Boarman was brought before the court and the judge, in a most impressive manner, pronounced the death sentence, naming Friday, November 17, as the day when the death penalty should be inflicted. The prisoner stood motionless while the death sentence was being delivered and showed no outward sign of fear. It is reported that a bill of exceptions has been prepared by Boarman's lawyers and that the case will be appealed.

Clarence Alford, charged with the same crime, will be tried at the January term of the Marion circuit court. As stated in last week's ENTERPRISE, the jury that tried Boarman was composed of eleven men from Boyle county and one from this county. After the rendition of the death sentence, Judge Thurman granted a stay of execution for sixty days pending an appeal of the case to the Court of Appeals and ordered that Boarman be sent to the Jefferson county jail to await the action of the higher court.

TWO CHANGES IN FIRMS.

TO DIE THIS MORNING.

John Bowman, who was convicted in the Marion Circuit Court in October, 1911, of criminally mistreating Minnie Deering, the 15 year old daughter of John Deering, and sentenced to die for the crime, will unless Gov. McCroskey last night commuted the sentence or granted a respite, die in the electric chair at the Eddyville penitentiary early this morning. After the man has been pronounced dead the body will be turned over to a local undertaker, who is now in Eddyville, and brought to this city for interment.

The crime for which Bowman will pay the penalty with his life was committed at the Sulphur Springs one mile east of this city the latter part of February, 1911. It took place on a Sunday afternoon and when news of the affair spread it caused a great deal of indignation. Bowman and Clarence Alford, who it was said, was also deeply implicated in the crime, were arrested a few days later and placed in jail. So strong did the feeling against the two men become the authorities removed them to the Jefferson county jail for safe keeping. Bowman was tried in October, 1911, by a jury composed, with one exception, of Boyle county men. He was found guilty and sentenced to die. The case was taken to the Appellate Court and affirmed. For more than a year Bowman has been awaiting death at the Eddyville penitentiary. Alford was more fortunate than his companion. He was tried and convicted and sentenced to the penitentiary for a term of from ten to twenty years. He is now serving his sentence at the Frankfort penitentiary.

The Deering girl's story of the crime was an unusually pitiful one. At the time she lived with her parents near Simms, but was visiting her sister, Mrs. John Caccio, who lived with her husband on his farm of E. N. Wathen near town. She said that Bowman, whom she had known for only a short while, drove to the Caccio home the afternoon the crime was committed about five o'clock and asked her to go driving with him. She told him, she said, that it was too late, but when he said he would drive only a short distance out the road she consented and got into the buggy.

They drove to the Sulphur Springs, there they were joined by Alford, who earlier in the afternoon had been seen with Bowman driving about town and who had, it was said by arrangement walked in the spring to meet Bowman. The girl said she begged the man

not to harm her and to take her home, but that they paid no attention to her entreaties. According to her story, she was made to drink whiskey and they threatened her life, but notwithstanding these facts she resisted them until she had been cruelly beaten and her strength was completely exhausted. She was then shockingly mistreated by both men. She said that Bowman later brought her home and told her if she divulged what had taken place he would kill her. The girl immediately upon her arrival home told her sister of what had happened. Her clothing was torn and partly besmirched with blood. She exhibited a number of wounds as evidence of the frightful ordeal through which she had passed.

The pitiful story told by the girl was in part corroborated by three well known young men of this city who visited the springs that afternoon and saw Bowman, Alford and the girl there. They said that Bowman was drinking and had a bottle of whiskey which he made no effort to conceal. They heard the girl ask to be taken home and said she had evidently been crying.

Bowman on a previous occasion was indicted for mistreating a girl while returning from a dance at New Market. He was tried twice but never convicted and was finally acquitted, the evidence of Alford being largely responsible for his dismissal.

Mindful of the uncertainty of life and ever practicing the duties belonging to his station, he was a God-fearing, Christian, charitable man, giving to the poor and ever ready to lend a helping hand to those in distress. Many friends and acquaintances extend sympathy to the sorrowful family in their great bereavement.

DEATH CLAIMS MRS. YOWELL.

Mrs. Mattie Lue Yowell, wife of J. Q. Yowell who lives above Bradfordsville, died at her home on Thursday morning, October 19, 1911, after an illness of several years duration. Mrs. Yowell was about 48 years of age at the time of death. Funeral services were held Saturday morning at Pleasant Valley church, conducted by Rev. Joseph Montgomery, and the interment was at Old Liberty burying ground. She is survived by her husband and two daughters, Mrs. Mary Swiggett and Mrs. Estell Adams, both of whom live in this county; also by one brother, two sisters and one half brother.

Mrs. Yowell was formerly Miss Mattie Weatherford, daughter of Thomas Weatherford, a prominent citizen of the Bradfordsville section. In October, 1888, she married J. Q. Yowell, a son of Hardin Yowell, and a brother of Chief of Police William Yowell of this city. Mrs. Yowell was a splendid Christian woman and greatly loved in the community in which she lived. Many friends unite in expressing sympathy to the family in their great bereavement.

DEATH OF WILLIAM FENWICK.

William Fenwick, a well known citizen of the county, died at his home at Raywick last week, after a brief illness of a complication of diseases. He was 60 years of age at the time of death. The funeral services were conducted by Rev. A. C. Zoller at St. Francis church at Raywick, and the interment was in the cemetery there. Mr. Fenwick was a Union soldier and served through the war with honorable distinction. He was an honorable man and will be missed in the community in which he lived. He is survived by his wife, four daughters and two sons.

DIES AFTER SHORT ILLNESS.

Beradine, the 17-months old daughter of Mr. and Mrs. A. R. Burke, died at the home of its parents at Loretto Sunday evening, after a illness of only one day. The child was in perfect health Saturday night when it was taken with convulsions, which caused her death. The funeral services were held Tuesday morning at St. Michael's Chapel, conducted by Rev. J. O. Stokkason, and the interment took place in the cemetery there. She is survived by her parents, one sister and one brother who are the sympathizers of the entire community.

EXAMINING THE ESTATE.

NEW TRIAL DENIED BOARMAN.

Circuit Judge J. H. Thurman on Saturday, the last day of the recent session of court, overruled a motion for a new trial in the case of the Commonwealth against John Boarman, convicted and sentenced to die for assaulting Minnie Lamb, a 17-year old girl residing in the extreme northeastern part of the county, last February. At one o'clock in the afternoon Boarman was brought before the court and the judge, in a most impressive manner, pronounced the death sentence, naming Friday, November 17, as the day when the death penalty should be inflicted. The prisoner stood motionless while the death sentence was being delivered and showed no outward sign of fear. It is reported that a bill of exceptions has been prepared by Boarman's lawyers and that the case will be appealed.

Clarence Alford, charged with the same crime, will be tried at the January term of the Marion circuit court. As stated in last week's ENT (ENT), the jury that tried Boarman was composed of eleven men from Boyle county and one from this county. After the reading of the death sentence, Judge Thurman granted a stay of execution for sixty days pending an appeal of the case to the Court of Appeals and ordered that Boarman be sent to the Jefferson county jail to await the action of the higher court.

TWO CHANGES IN FIRMS.

Messrs. Ward and Lewis Edmonds have purchased from the estate of the late A. H. McChord the stock and good will of the firm of McChord & McChord, and will conduct the business under the name of Edmonds & Bru, thus reviving one of the oldest and best known firms in the city's history. Both gentlemen are well known. Ward Edmonds has been with McChord & McChord since the business was established five years ago. He is thoroughly conversant with every detail of the business, and in its conduct will have a valuable assistant in his brother, Lewis Edmonds. The latter has been the efficient head bookkeeper for the Lebanon Lumber Co. for a number of years past. He has tendered his resignation, but will remain with the company until his successor is chosen.

On Monday C. W. Hagan, of this city, sold his half interest in the meat and grocery business of Thompson & Hagan, on the corner of Main street and Spalding avenue, to T. M. Eates. The consideration was private. Mr. Hagan retires from the business on account of his health, and expects to spend the coming winter at Hendersonville, N. C. Dan Thompson will continue in active charge of the business.

THREE FARMS SOLD.

At the sale of the L. D. Mattingly land near St. Mary's Tuesday a large crowd was present and the bidding at times was quite spirited. The personally, consisting of household and kitchen furniture and farming implements, was offered for sale first and brought good prices. Only a few head of stock were sold. Those offered brought the following prices: 1 7-year-old stallion, \$14; 1 6-year-old brood mare, \$106; 1 aged mare, \$17; 1 pair horse mule, three years old, \$230; 1 yearling horse mule, \$87. The home place, consisting of 127 acres of land, was purchased by Hugh Mattingly at \$46 per acre, and 61 acres of land, lying near the Brown-Poem Distillery, was purchased by Col. A. P. Anderson, keeper of the National cemetery, for \$1,430.

The sale of W. O. Buckler on Monday was well attended and the bidding on personal property spirited. The farm of 90 acres was withdrawn at \$2,650. Farm implements, household goods, buggies &c. sold well.
