Robert Abell, son of Samuel Abell III; died in Maryland Sept 1802, age 46 years; married Margaret Mills, Nov. 3, 1777 in Maryland. She died Feb. 19, 1818, age 59 years, at St. Thomas Ky. After several years spent around Loretto, he undoubtedly selected Calvary as a place of settlement for his kin and neighbors of St. Mary's County, Maryland. Robert and his oldest brother Samuel Abell IV bought lands on Cloyd's Creek near the river. He was recommended for magistrate in 1788 with Hanna Lincoln, a gentleman. He was elected several times to represent Nelson and then Washington County in the Legislature and as member of the first Constitutional Convention. As a magistrate he presided in the first term of the Washington County Court in Springfield in June 1792. He was a sort of country lawyer, wrote many wills, deeds and other instruments, but does not seem to have had the thrift usual in his family. His little fortune was soon gone and becoming involved in debt in 1802 he left Kentucky for no known reason and went back to Maryland on a ship where it is said he died.

W. BUCKMAN and Susan also signed -- "CHARLEY HENRY BUCKMAN acknowledged 4/5/1852 and REV. THOMAS J.L. BUCKMAN, OSP acknowledged 10/8/1851."

JAMES W. BUCKMAN farmed near St. Rose's. Then the family moved to New Haven, Kentucky where JAMES W. BUCKMAN ran a dry goods store. Susanna died prior to 1850. JAMES W. BUCKMAN died in 1856 at the age of 70.

JOSEPH BUCKMAN (22) was born in 1787 in St. Mary's County, Maryland, the son of CHARLES BUCKMAN (4) and Jane Dunbar. As a young lad he accompanied his parents to Washington County, Kentucky. In Washington County on 7/11/1807 he married Elizabeth "Betsy" Abell (b 7/24/1788 in MD, d 2/10/1831 buried Holy Mary), the daughter of Robert Abell and Margaret Mills. Rev. Charles Nerinckx performed their wedding ceremony at Holy Mary, Calvary, Kentucky.

In the 1810 census of Washington County, JOSEPH BUCKMAN is listed with his wife, one son and one slave. JOSEPH BUCKMAN purchased 190 acres on the Rolling Fork River from Samuel W. Venable (Deed E:458). In the 1820 tax list JOSEPH BUCKMAN had 185 acres on Rolling Fork and two horses. His first wife Elizabeth died shortly after the birth of their daughter SUSAN REBECCA.

At St. Joseph's in Bardstown on 7/23/1831 JOSEPH BUCKMAN married secondly Harriet Drury, the daughter of Ignatius Drury. They resided first in Marion County and then in Nelson County. Their three youngest children were baptized at St. Joseph's in Bardstown. Harriet died in 1845.

At St. Joseph's in Bardstown on 11/20/1847 JOSEPH BUCKMAN married thirdly Mrs. Teresa Clancy Horrell, the widow of Henry Horrell. Their marriage ceremony was celebrated by Rev. B.J. Spalding. Teresa had four children from her first marriage who were baptized at St. Joseph's in Bardstown: John Richard Horrell b 9/23/1827; Bernard Horrell b 4/1/1829; Margaret Ellen Horrell b 12/22/1830; and Rebecca Frances Horrell b 4/17/1832. JOSEPH BUCKMAN and Teresa Clancy Horrell had no children.

In the 1850 census of Nelson County, JOSEPH BUCKMAN and Teresa are listed with four children: HENRIETTA BUCKMAN, ELIZA BUCKMAN, JOSEPH BUCKMAN and JOHN BUCKMAN - all children from JOSEPH BUCKMAN's second marriage. JANE BUCKMAN, the youngest child of the second marriage, was living with her oldest half-sister MARY ANN "MOLLIE" BUCKMAN in the household of MARY ANN's uncle, Rev. Robert Abell, in New Haven, Kentucky.

After their marriage JOSEPH BUCKMAN and Teresa purchased a lot in Bardstown from Turner Wilson for a mortgage of \$158.50 (Deed 26:14). On 10/14/1852 Teresa Buckman died and was buried at St. Joseph's Cemetery several blocks from their residence. Two years later on 8/29/1854 the lot and house on Main and Strawberry Street was sold to pay the debt owned by JOSEPH BUCKMAN and Teresa to Turner Wilson. James Slaughter purchased the lot and house.

According to the Kentucky Vital Statistics, JOSEPH BUCKMAN died on 4/10/1859 at the age of 72 in Nelson County. The record states he was the son of CHARLES BUCKMAN and that he had died of old age.



BARDSTOWN, KENTUCKY

Bardstown, Kentucky, the area where JOSEPH BUCKMAN (22) spent at least 30 years of his life, is nestled in the heart of Kentucky among hills, springs, and friendly winding roads. On the slopes surrounding Bardstown are the once famous family-owned distilleries, now mostly run by large corporations. My old Kentucky Home - The Rowan Mansion - is a famous piece of architecture in the town. Other lovely historical structures are Federal Hill, the home of three governors, and the picturesque Old Talbott Tavern.



St. Joseph's Cathedral, the third in the United States and the first west of the Allegheny Mountains had its cornerstone laid on 7/16/1816. Some BUCKMANs might well have been present on this unusual occasion. The Church was consecrated on 8/8/1819.

Bardstown was the forerunner of the Archdiocese of Louisville. On 2/2/1995 Bishop Charles G. Maloney, auxiliary bishop emeritus of Louisville, was named to the honorary title of the first Titular Bishop of Bardstown when the former diocese was re-established as a titular see, one of only three in the United States. Titular Diocese are named to "keep alive the memory of places that were important."

St. Joseph's has historic value, and is also a shrine of art. A great number of tourists yearly visit the area and view the masterpieces the Cathedral houses.

Bishop Flaget, the first and only Bishop of Bardstown, Kentucky, received nine Master paintings from generous friends in Europe. The paintings are said to be the work of Van Bree, Jacob Hast and other nineteenth century European artists.

When Archbishop Kelly petitioned the Holy See to re-establish Bardstown as a titular diocese, his reason was "to maintain the title of the center of the Catholic faith in Kentucky as intimately involved with the church's ministry of bishops" (Information from 2/17/1995 MESSENGER).

A certificate from the Department of the Interior, Washington, D.C. states:

The historic building known as St. Joseph's Cathedral in the County of Nelson and State of Kentucky has been selected by the Advisory Committee of the Historic-American Building Survey as possessing exceptional historic or architectural interest and as being worthy of most careful preservation for the benefit of future generations and that to this end a record of its present appearance and condition has been made and deposited for permanent reference in the Library of Congress.

The year following the consecration of St. Joseph's Cathedral Bishop Flaget built St. Joseph's College on

URBAN A. BUCKMAN (117) was born 2/22/1815 in Washington County, Kentucky, the son of JOSEPH BUCKMAN (22) and Elizabeth Abell. He married first Henrietta Mattingly, who died following the birth of their second child. At St. Michael's in Fairfield, Kentucky on 6/10/1845 he married secondly Tabitha Cecil. Their three oldest children were baptized at St. Michael's. Then they moved to Daviess County, Kentucky where their next three children were baptized at St. Lawrence's. The family is listed in the 1850 census of Daviess County, and his brother GEORGE T. BUCKMAN, a wagon maker, is residing in their household. Then the family moved to Spencer County, Kentucky. The Catholics in Spencer County were administered to by the priests from St. Michael's in Fairfield until the opening of St. Benedict's in Spencer County. Their other children were baptized at St. Michael's. URBAN A. BUCKMAN died 10/6/1893. He and his wife are buried at St. Benedict's in Taylorsville.

ROBERT BUCKMAN (118) was born 10/31/1818 in Washington County, Kentucky, the son of JOSEPH BUCKMAN (22) and Elizabeth Abell. In Nelson County, Kentucky on 11/16/1839 he married Teresa Shircliff (b 1/22/1822, d 3/10/1888), the daughter of Joseph Athanatus Shircliff and Elizabeth Walker. Rev. Robert Abell, his uncle for whom he was named, performed the wedding ceremony.

They were living in Hardin County, Kentucky when on 3/3/1853 they sold land in Nelson County which they had received from Joseph Shircliff, the father of Teresa, to Raymond Shircliff (Deed 28:235). A deed was recorded in Hardin County on 2/9/1854 in which ROBERT BUCKMAN purchased land from Raymond and Susan Shircliff. The deed says "exchange of deeds" (B#1:193).

In 1840 ROBERT and Teresa BUCKMAN moved from Marion County, Kentucky to Stithton, Kentucky (now Fort Knox). Here they spent the remainder of their lives, living on property directly across from the Chapel at Fort Knox, which at their time was St. Patrick's Church. A Chapel had been at St. Patrick's starting in 1831 when Father Coomes first recorded baptisms. On 11/30/1853 Ignatius and Mary Ann Corbett deeded land for St. Patrick's Church to Bishop Martin J. Spalding. The tract bordered on ROBERT BUCKMAN's land (Deed 1:61). ROBERT BUCKMAN, his wife, and eight children were members of the parish in 1853. This Church served the Catholics of the area, with Mass being said by priests from Bethlehem Academy. After

Farm Accident Is Fatal To Buckman Youth

John Dale Buckman, 10-year-old son of Mr. and Mrs. Robert R. Buckman, Route 1, Lebanon, was killed at 4:30 p.m. Saturday when he was trapped in a grain bin on the Campbellsville Highway farm of his grandfather, Ray Buckman.

The Buckman youth, who was known as "Jack," was with his father on the elder Buckman's farm when the freak accident took place. Members of the family said the youth's father was mixing small grain at a barn. In this operation the mixture of wheat and barley was being taken through a small opening in the bottom of the eight-foot deep bin, by means of a portable mixer, attached to a tractor.

The Buckman youth evidently was standing in the bin during the operation. The grain falling from the sides of the bin, and the void in the center of the bin, trapped the youth. The youngster called for help but efforts of his father to shovel the grain away, or to pull the boy from the bin, were unsuccessful. A neighbor, Albert Smothers, helped the boy's father remove the youth from the bin and he was rushed to Mary Immaculate Hospital, but was dead on arrival there.

The accident victim, who was a fifth grader at St. Charles Elementary School, is survived by his parents, Robert R. and Pauline Malone Buckman; two brothers, Danny Ray and Robert Gerald Buckman, both at home; three sisters, Sheila Marie, Julita Catherine and Sue Ann, also at home. Also surviving are his grandparents, Mr. and Mrs. James Malone, Raywick, and great-grandparents, Mr. and Mrs. George L. Thompson, Sr., Route 1, Lebanon.

The body was at Bosley Funeral Home until time for the funeral services which were held at 10:30 a.m. Tuesday at Our Lady of the Hills Church, Finley. Burial was in the church cemetery.
