# Genealogy From The Long Ago (OLD SCRAPBOOK - 1890)


*Editor's Note: We have come across an interesting collection of old clippings dealing with Kentucky family history. Since these clippings are over 100 years old, your editor feels they will be of interest to many of our readers. We will continue this column each month until the supply is gone.*

## *Fowler*

The name Fowler is listed in Barber's *British Family Surnames* as derived from the French personal name "Fouiller," but it is also an occupational surname. Marshall's *Genealogist's Guide* shows that there were families of Fowlers in many English shires, but no connection is found in England to this Fowler family, it seems to begin in Virginia.

The first Fowler to whom we can trace is Richard Fowler, who is listed in the 1704 Charles City County Quit Rent Roll with 150 acres. Charles City County lies to the west of James City County and adjoins New Kent on the North, which, in turn, adjoins King William County. It was therefore no great journey for him to move to King William County, where on July 9, 1724, we find him domiciled and patenting 420 acres of "new land" lying on both sides of the Stony Lick Branch, binding upon the back of Zachary Martin's upper tract in St. John's Parish. Upon the creation of Caroline County in 1727, Richard Fowler's land lay in that county. In 1729 Richard and Francis Fowler patented 137-1/2 acres in St. Margaret's Parish, Caroline County, adjoining Richard Fowler's own land and the land of William Marshall. The first extant Caroline County order book covers the years 1732 to 1740 and has the following entries. Richard Fowler's deed for land to Francis Fowler was proved in court July 12, 1733, by George Goodloe, John Alt and George Eastham. On May 9, 1734, the will of Richard Fowler was presented in court and proved by George Goodloe and John Alt, two of the witnesses thereto. Francis Fowler, son and heir of Richard was summoned to next court to

show cause if any, why his deceased father's will should not be proved. At the next court, June 13, 1734, the will of Richard Fowler was further proved by Sarah Fowler and William Marshall, the executors therein named; George Goodloe, John Ellis, William Durrett and Zachariah Martin or any three of them were appointed to appraise the estate. The following March, the suit brought by Francis Fowler against Sarah Fowler and William Marshall, ex-


ecutors of Richard Fowler, deceased, was "dismissed." On March 13, 1737, Francis Fowler, Rebecca Fowler, Sarah Fowler, and William Fowler, the said Rebecca being first privily examined, acknowledged their deed to Daniel Trigg.

Richard Fowler's oldest son was Francis and his widow was Sarah. In the deed to Daniel Trigg, which likely wound up the estate, Rebecca was clearly Francis' wife, hence had to sign with him, Sarah of course, and executrix and in her own right signed. William must have signed as a legatee and son of Richard, hence we shall so consider him. Richard likely had also a son, Richard, as a Richard appears in Spotsylvania County records several times, in 1739 and 1740. He probably joined the others of his family in Frederick County.

No Fowler references have been discovered in Orange County records, and we find Francis Fowler next in Frederick County, where in 1744 he sues Leonard Harper. The next year he was sworn constable in the precinct of John Hampton who most likely had also come from Caroline County. In 1747 Richard Fowler, probably a son or brother, was appointed constable to succeed Francis. Other references in will and order books reveal Francis and Richard serving as witnesses, appraisers and securities for their friends up to nearly 1760 when both disappear from the records. Records in Hampshire, Berkeley, and Hardy Counties, West Virginia, and in Frederick County, Maryland, furnish no solution to the puzzle of their whereabouts, although a Richard, probably a later generation of the family, appears in Madison County, then a part of Virginia, later a part of Kentucky.

Whether being a merchant, William Fowler was frequently out of the county or whether he was residing in his wife's county of Prince William, we do not know, but he does not appear in Frederick County records until about 1754. From then until his death he is often in court trying to collect money due to him.

In 1766 William's wife, Mary, daughter of David and Ann Jones, charged him with cruelty and abuse and sued for separate maintenance. After some months, the case was "dismissed, having been agreed."

In 1770 William died intestate, and Mary was granted administration on his estate. At the same court, May 1770, she was granted a license to keep an ordinary the ensuing year, "she having complied with the law." The appraisement of the estate ordered at this court was not returned until August 1771. We can safely assume that William Fowler's business had declined as had most businesses in the economic depression preceding the Revolution, else his widow would have not so quickly have started an ordinary means of livelihood.

By 1774 Mary Fowler had married Adam Halker, a merchant, and they were living in that part of Frederick that became Shenandoah County.

Little is known of Mary's parentage, with the earliest identification of the Jones family to which she belonged begins with the will of Robert Paine of Hanover Parish, Richmond County, dated March 16, 1716-1717, and proved April 3, 1717, in which he makes a bequest to David, son of Lewis Jones. Lewis Jones on the formation of King George County in 1720 became a resident there, as this entry shows: "Elizabeth Jones, widow, came into court and

made oath that Lewis Jones, deceased, departed this life without making any will so far as she knows or believes, and on her motion and giving security for her just and faithful administration of the said estate, certificate is granted her for obtaining administration in due form." The next year, November 2, 1722, she complained that the ferry road going to her plantation was troublesome, whereupon the court appointed Thomas Turner and Benjamin Strother to view it and see if changes could be made. On February 1, 1722-1723, Thomas Bartlett and Elizabeth, his wife, late widow and administratrix of Lewis Jones, deceased, petitioned that since she has paid all bills, etc., against the estate, her dower in said estate may be set aside for her. The court appointed Thomas Turner, William Strother, and Francis Woffendall to do this. In 1725 Thomas Bartlett, with William Miller, Thomas Dickenson, Henry Long (Jr.), and Robert Johnson, as his securities, gave an indemnifying bond to release from obligation Samuel Wharton, who at the request of Elizabeth Jones, then widow of Lewis Jones and now wife of said Bartlett, had gone security in the

sum of 500 sterling on Elizabeth's administratrix's bond. Thomas Bartlett died about 1748, as his will was presented in court October 17, 1748. The will is lost in the King George will book.

We have proof of only two children of Lewis and Elizabeth Jones, viz. Sarah, on whose estate in 1726, David as being her brother, secured letters of administration, and David.

David was born probably about 1699, he was likely under 21 in 1717 since Robert Paine's will describes him as "son of Lewis Jones," but in 1720 was witness to a deed. In 1724 James Kay sold land in Hanover Parish, noting it as part of the tract on which he himself lived, "and includes the plantation which David Jones now holds as tenant." As David of Stafford County, he petitioned in 1729 for 300 acres of waste land "lying between the long branch of Accotinck and the Doge Runs, binding on the lands of John Herryford, William Williams and the land of Nicho Carrel but assigned it April 30, 1730, to John Gladding, in whose name it was surveyed by James Warner. On the formation of Prince William, David Jones became a resident there, and in 1732 John

Samuel Boone, oldest brother of Daniel Boone, died in Fayette County, Kentucky, in 1816 at the age of 88.

Herryford of Prince William County leased to David Jones and Anne, his wife, of Prince William County, a tract of land on the north side of the Accotinck Run being part of a tract formerly taken up by John Herryford's father. This land was most likely part of 2,249 acres patented January 4, 1714-1715, by James Herryford and Col. George Mason. In 1741 David Jones was still in Prince William County, as he appears among those voting in the poll for burgesses. There is a gap of 22 years, presumably because of the lack of Prince William County order books from 1730 to 1752, and we find next that David Jones has crossed the mountains and is a resident of Frederick County, where his daughters had lived for some years. Jacob Miller and Barbara, his wife, of Woodstock, for two pounds current money, conveyed to David Jones half-an-acre, being lot 19, in the town of Woodstock, being part of 400 acres granted April 2, 1752, to said Miller, and subject to the condition that he erect on the said lot one good dwelling home with a stone or brick chimney. David Jones patented a certain waste and engrafted tract of land on a drain of Hoge's Creek on the south side of the North Mountain in Frederick County containing 90 acres. In 1775 Adam Halker and Mary, his wife, and Morris Morgan and Ann, his wife, all of Dunmore County, conveyed to Gaspar Lerrick, of Frederick County for 40 pounds current money of Virginia 90 acres on a drain of Hoge's Creek on the south side of the North Mountain in Frederick County, "being land formerly granted to David Jones by deed from the proprietors of the Northern Neck dated May 5, 1763, and David Jones being dead and leaving no lawful heirs but the above mentioned Mary and Ann the said land devolved to them."

Maurice Morgan, husband of Anne Jones, had been in Frederick County by 1762 at which date he patented land lying on both sides of Issac's Creek and lat-

er added to his holdings. On the creation of Dunmore, later Shenandoah County, he, like the Fowlers and Halkers, became a resident of the county. On August 28, 1778, Anne Morgan with Abraham Bird and Joseph Pugh gave bond to administer on the estate of Maurice Morgan and the following February, Reuben Allen, Sr.; Joseph Hawks; and William Smith returned the inventory and appraisement. In 1796, probably at Anne's death, the estate account of Maurice Morgan was submitted by Abraham Bird, one of the administrators, and returned by George Fravell and William H. Dulaney. There are no guardians' bonds

nor accounts to tell us of any Morgan children, nor do Shenandoah tax lists show any land held by the estate of Maurice Morgan. In 1787 Anne makes her one and only appearance in the personal tax lists.

Mary Jones married William Fowler and (second) Adam Halker. There is no list of her Halker children but from a descendant, the Rev. Twyman Williams of Hampden-Sydney, Virginia, we learn there was at least one child, a daughter, Mary, who married on March 15, 1796, Andrew Bird. The Rev. Alexander Balmaine's account book (1782-1821), shows that on January 29, 1798, he officiated at the marriage of Samuel Hughes to Catherine Cooper Halker. Catherine may have also been a daughter of Adam and Mary. In 1772 Adam Halker purchased from Henry and Barbara Ott and Woolrich Miller lot number 115 in Woodstock. The next year Israel Christian of the parish and county of Fincastle, leased to John Alderson and Adam Halker, merchants, of the parish and county of Botetourt, that tract of 100 acres more or less known by the name of Miller's Mill for seven years for 30 pounds of current money annual.

Adam must have returned to Shenandoah quickly, for in the same year he petitions for a road from his place to Christian Stickney's on the main road lately cut out, leading from Winchester to Staunton, commonly called Zane's Road. In 1794 Adam and Mary conveyed a lot in Woodstock to David Geyer, and that is the last we know of them.

William Fowler, son of Richard and Sarah Fowler of Caroline County, born by 1716 since he signed a deed in 1737, married Mary, daughter of David Jones about 1750, who was likely some years his junior. As often occurs when a person dies intestate, we have no documentary proof of his children. In 1772 the court instructed the church wardens of Norborne Parish to bind out Elizabeth Fowler, who on May 15, 1772, would be

nine years of age, to Andrew Bowman and Rebecca Fowler, who on April 1, 1772, would be seven years of age, to John Wilson. These entries are indexed under "Orphans," but the items themselves do not use the word and there is no clue to Elizabeth's and Rebecca's identity. We consider William had certainly one son, William, Jr.

In Dunmore (Shenandoah) County rentals for 1774, William Fowler is charged with 90 acres. The arrears therefore began in 1771, and William must have been 21 then, hence born about 1750. He did not administer on his father's estate in 1770, as he would have likely have done had he then been of age. In Brumbaugh's *Revolutionary War Records*, in a list of tithable of Dunmore County, taken November of 1775 by Richard Campbell, Maurice Morgan, William Fowler, and Adam Halker appear consecutively indicating they lived near each other. He had numerous dealings with Adam Halker and every indication points to his being the son of William Fowler, merchant, of Frederick County.

Like his father and stepfather, William was a merchant and Shenandoah records are full of his suits brought to collect debts due him. No entry to his discredit is found. At one time he was associated with Benjamin Fawcett under the name of "Fowler & Company" Benjamin Fawcett's letter dated May 31, 1787, addressed to Francis Ravinhill asking for extension of time on an overdue note he and William Fowler had given to Adam Halker lists certain assets. "Two hogsheads of tobacco at Colonel Beal's loaded to be sent down as soon as possible and I am informed that it sells for cash, also have got fire in the furnace Monday last. I think with luck it will be in my power before June court either by iron or tobacco to raise the cash to discharge the account." When the tax list was taken on June 13, 1799, William was dead, and "Nancy Fowler removed." In December the sheriff reported "William Fowler is said to be dead. I was at the house of the widow Fowler and could find no person in it or about it."

Ann was the daughter of William Bradford and Mary Morgan of Fauquier County, and had availed herself of this opportunity to return to the place of her birth where many of both her father's and mother's people still resided. Ann was born about 1756 and married by 1774.

William Fowler, Jr., had died intestate as his father had done, but while we could prove neither brothers nor sisters for him, we can prove his seven children.

Mary (Polly) was the first child mentioned, giving bond to administer on Mary's estate with Isaac Strickler as his security.

Charles M., probably the oldest son, seems to have gone to Kentucky early. Charles M. married on April 20, 1807, in Bourbon County, Kentucky, Lydia Heaton. He served in the War of 1812 and died of cholera in 1833, buried at Claysville, Robertson County, Kentucky. The children of Charles M. and Lydia were William H., Benjamin, Henry, Mary (Polly), Delilah, Lydia Ann, Bradford, and John. William H. (died about 1854) married first, on February 17, 1838, Matilda Barber, marrying second Mrs. Hannah Whitley Ashcroft, issue; Benjamin married December 22, 1828, Elizabeth Foley; Mary (Polly) married December 19, 1829, Joseph Arnold; Henry and Bradford served in the Mexican War; Henry is probably the person of that name who married in Harrison County on November 11, 1839, Nancy McDaniel; Delilah, probably died unmarried about 1888 in Harrison County, and John died of cholera at Louisville, Kentucky, unmarried.

John H. Fowler went to Kentucky also, and in 1812 in preparation for his departure for war, made his will as follows: "Know all men by these presents that I, John H. Fowler in case I should never return, leave to my sister, Elizabeth Fowler, all my part of the estate coming to me in Virginia, also in case I never return, I leave in the care of my brother, William R. Fowler, all my property in the state of Kentucky for the support of my mother, Ann Sandsbury. As witness my hand and seal August 7, 1812." Alexander Lewis was the subscribing witness and proved the will at the April court of 1813.

Elizabeth, the sister of the testator,

married in Harrison County, Kentucky, on December 15, 1815, Alexander Lewis, but the marriage was of short duration. The will of Alexander Lewis dated November 20, 1820, witnessed by M. Moore and Alexander Lewis, Sr., was proved May of 1821. In this he devises, after his debts are paid, this property of every kind to his wife, Elizabeth Lewis, for her life, and then to his children, Malvina and Amanda. Wife and William Fowler to be executors.

William R. Fowler was also in Harrison County, Kentucky, and married there, August 22, 1822, Sarah Lewis. He bought land at intervals from 1823 to 1839, at which time the records end for him and we have no further information.

Nancy Fowler was born in Shenandoah County in 1780 or 1781 and died in Rockingham County, 1875, married April 8, 1800, Joseph Hiden (then known as Joseph Jones.) In Shenandoah County court in April of 1800, Joseph H. Jones, with John Hup as his security, gave bond as guardian of Nancy H. Fowler, orphan of William Fowler.

Henry Fowler, whose deposition relative to his sister, Nancy, lived in that part of Rockingham, later Page County. Joseph Hiden, born 1852 and died in 1937, grandson of Nancy Fowler Hiden, told that he remembered his uncle Henry Fowler, who would come to Harrisonburg on business and stop en route to see his sister. Henry died of old age at the age of 83 years at Grove Hill. He married twice, marrying second Susannah Lineberger on February 18, 1819. The name of his first wife is unknown.

In Mrs. Estelle King's *Kentucky Wills*, among the records of Caldwell County, Kentucky, is the will of a Geoffrey Fowler, dated December 20, 1816, proved February 1817. In this he mentions his wife, Clara, who with son, James, is made executrix and legatees. Termed, James, John, Wiley, Bradford, Polly, and Ida.

William "Earl" Fowler (1899-1964), son of James Durwood and Mary Frances Perry Fowler, and Opal Irene Graves Fowler (1913-1999), daughter of Elbridge "Ebbie" Porter and Milinda Victor Saylor Graves, operated Fowler's Store in the Chapel Hill community of west Allen County, Kentucky, during the 1950s to the late 1970s. Earl and Opal, who were both Allen County natives, married on March 27, 1930, in Marion County, Indiana. Their children included Earl Fowler (1932-?), twin girls, Katherine Loyce (1942-1942) and Linda Joyce (1942-1942); Wanda "Sue" Fowler Woods (1944-?); Billy Earl Fowler (1948-1992); Glenda Gail Fowler Rippy (1951-?); and Carol Fowler Baxter (1952-2015). After Earl's death, Opal and the family still stocked the shelves with household goods and food and sold gasoline. The old gas pumps are shown in the photo. The Traughber, Overholt, and Spivey families lived one-and-one-half miles south of the store on a country gravel road, of which the school bus could not navigate because of public school guidelines. During the school year of 1962, Glen "Sonny" Traughber (1924-1993) along with his four children: Tommy, Nancy Jo, Anita Kaye, and first grader David Wayne Traughber, picked up first grader Harris D. Overholt, usually in the old pickup truck to catch the bus at the Fowler Store. The store was one of the bus stops for children attending White Plains Elementary and Allen County High School in Scottsville. If by chance, the bus was missed at Fowler's store, there was a dash made for Herbert "H. R." Graves (1911-1988) Store about two miles toward town. Graves Store was the last bus stop running from the West where the Graves children were picked up and of course anyone else who was late. Shown at the left side of the photo is the family entrance of Opal's residence that was joined on the back and left of the storehouse building. Chapel Hill is located six miles west of Scottsville which was a thriving community comprised of storehouses, a switchboard, masonic hall, photographer, churches, schools, etc. in the late 1800s through the motorcar age of the mid 1900s. The only business remnant left today, besides the churches, is of the Mayhew's Store that is used as a residence in the downtown area of Chapel Hill. In this undated photo, Opal is poised to "gas up" a customer with Chevron gasoline and the children have been "shooed" away, as their tricycles and toys remain on the porch. The right post holds the air line for inflating tires and the kerosene tank is beside the bench under the right hand window. The Fowler family members are buried at Walkers Chapel United Methodist Church Cemetery about two miles west of the storehouse. H. D. 
