# How Water and Light Came To Springfield

Are you one of those who can remember back over the space of time to the year 1896? That means looking back 42 years—eight years short of a half-century.

Well, if you are, you can remember when the town of Springfield became water and light conscious in a big way.

From year to year, beginning in 1793 when the town of Springfield was established by an act of the Kentucky General Assembly, down to 1896, the problem of adequate and pure water supply had been an ever-present one. In the earlier years the town's inhabitants depended upon the several fine springs that flowed within the town limits or adjacent thereto. These springs were under strict supervision and heavy penalties were imposed upon all persons who violated town ordinances enacted to protect this initial source of water supply for the citizens of the county seat of Washington County.

Then came the day when the population of the town outgrew the springs, or perhaps, the springs failed to flow as freely as in the past. The era of wells and cisterns was at hand. The Town Trustees caused several public wells to be dug to augment the springs and these, in company with the private wells that had been dug by a few inhabitants for their own use, constituted the solution to the water problem for the time being.

As the years passed, the problem of an adequate water supply for the town arose again and again, to be met by more wells, and finally, by the addition of several cisterns, conveniently located for use in case of fire. We have not taken the time to ascertain the locations of all of the public wells and cisterns within the town limits. In looking through an old record book of the Board of Trustees we found one entry made May 9, 1894, which specified that R. B. Curry be "appointed a committee to have well in front of his house dug deeper and also to perform all things necessary to the completion of said well."

Another entry for August 8, 1894, informs us that it was "ordered that a cistern 15 feet deep and 12 feet in diameter be dug in front of the Baptist Church property on Main Street and also a well be dug on Main Street near the property of W. H. McElroy."

There are other entries, no doubt, that one might find among the records, but these two were the last preceding the movement looking to a modern water supply system in 1896.

The story of the town's gradual advancement to the day of modern lighting run parallel with that of adequate water. While the inhabitants got their water from springs, wells and cisterns, they read, worked or travelled by night, with the aid of candles, oil lanterns and lamps, and later by gasoline lamps. The main street of the town was lighted, dimly at best, for many years, by oil lamps. Then came the gasoline lamps, the era of which extended for several years and ended with the advent of the electric light in 1896-97.

Prior to 1896 the town of Springfield evidently handled the town lighting as a public function, the Board of Trustees probably employing some person to discharge the work of keeping the lamp in repair and lighting them. We find an entry for November 18, 1894, and another for November 24, 1894, which seem to confirm this belief. The first informs us that "J. F. Green and Robert Noe were appointed a committee to correspond with Standard Oil Company in order to get terms, etc., from them for furnishing gasoline for street lighting purposes and to make necessary contract, etc." The second recites that "A. Cunningham and Robert Noe for and on behalf of the town of Springfield, Kentucky, entered with a contract with Standard Oil Company by the terms of which said Standard Oil Company is to furnish said town with deodorized gasoline for street lighting purposes at 7½ cents per gallon f.o.b. at Louisville, Kentucky, in iron drums, said town to pay freight on said drums both ways."

With the advent of the year 1896 it was determined that the town lighting should be let to the lowest bidder. There is an entry for January 6, of that year, which says, "a notice was to be put in paper that the Board would receive seal bids for lighting the town for one year beginning February 1st, 1896, and all bids be in by January 20, 1896."

At a call meeting of the Board of Trustees on January 20, 1896. "The bids for lighting the town for 1 year beginning February 1st, 1896, was opened and Dudley Tapp being the lowest bidder was given the contract."

So, the late Dudley Tapp began lighting the town of Springfield on February 1, 1896. It was while he was carrying out his contract, however, that the move to modernize the lighting and watering system was launched.

However, efficient Mr. Tapp and his predecessors may have been, the fact remains that the town had greatly outgrown the old system, just as it had advanced beyond the capacity for service offered by springs, wells and cisterns. The Town Fathers recognized this and frankly said so when they met for a call meeting on May 23, 1896.

"Whereas by reason of want of a sufficient supply of water and lights," they declared, "the business interests of the town of Springfield is greatly retarded and the citizens thereof are deprived in a great measure of such necessities and because there is not sufficient water system the fire insurance rate on property is so high that a large amount of property is not insured and the town is liable to be destroyed by fire at any time."

These facts being apparent, the Board believed that "ordinary prudence demands that the authorities of said town shall take steps to protect the general interest of said town." And, without further delay they did act, in manner as follows:

An ordinance was drafted and adopted which took cognizance of the

fact that "a number of citizens of the said town of Springfield have organized a corporation, known as 'The Springfield Water and Electric Light Company' with a capital stock of \$12,000 for the purpose of constructing water works and electric lights in, and for the accommodation of, said town . . . and whereas . . . said town of Springfield must own and have a majority of the stock of said company . . . and whereas the taxable property of said town amount to \$218,607.00 . . . and no debt of any kind against said town; said town may therefore create an indebtedness of \$6500.00 to pay for said stock and to that end it is proposed to issue and sell the bonds of said town of Springfield to the amount of \$6500.00 bearing interest at the rate of 6% per annum payable semi-annually and due 20 years after date . . . now, therefore, to test the sense of the qualified votes of the said town of Springfield . . . The Board of Trustees of the town of Springfield, Ky., ordain as follows that an election be held in the town . . . on the 13th day of June, 1896, between the hours of 7 o'clock A. M. and 4 o'clock P. M. . . said election to be by secret ballot."

The foregoing ordinance was unanimously adopted and the election was set for June 15, with A. C. Kimball and W. A. Waters, Judges; T. H. Waters, Sheriff, and W. E. Leachman, Clerk. The election was to be held at the Court House.

The Minute Book of the Board of Trustees for the year 1896 does not show the results of the election ordered for June 15. It is evident, however, that a majority of the "qualified voters" of the town approved the proposal, when we note that at a meeting of the Board of Trustees on July 10, it was ordered that "seventy five dollars" should be spent "one having the town and ground thereabout surveyed for water works and electric lights."

There was no further official action relating to the water works and electric lights proposal until the time of the regular meeting of the board on December 7, 1896. At that meeting a motion was made by C. L. Haydon and seconded by J. F. Green "that a committee be appointed to contract . . . for carrying out a plan to secure bonds to build water works for said town." The motion carried and the chairman appointed James C. Noe and C. L. Haydon. The Committee was to report at the next meeting.

The minutes for the next regular meeting (December 14, 1896,) do not mention the water works and electric lights subject. The attention of the Board was engaged wholly by a motion "that each of said property holders be compelled to pave in front of their property, namely, W. R. Curry, Kit Casey, Miss Bell Walls, Dr. Joe Mudd and W. A. Waters, J. R. Smith, R. H. Edelen, Mrs. Lee."

No installation of an electric lighting system having been effected by January 4, 1897, it then became necessary for the Board of Trustees to "let to the lowest and best bidder" the contract for "the lighting of street lamps." The bids were to be in by January 15. On that day the Board met and John Smith was found to be the lowest bidder. He was "employed by the Town of Springfield to light the lamps, the said town to furnish gasoline and all the repairs."

Throughout the year 1897, no official action was taken on the water and light project. The minutes show

# RESEARCH MAN SEEKS DATA ON LINCOLN FAMILY

Government Has Historical Worker In

Washington County's efforts to create a memorial in honor of Abraham Lincoln and his forebears has attracted wide-spread interest; so-much-so that the Federal Government has sent one of its historical research workers here to gather all available data pertaining to the Lincolns. This worker will remain here until all of the records of Washington County have been combed and every existing record relative to the Lincolns and their kinfolk has been copied.

An interesting explanation of what the Federal Government proposes to do in the way of gathering and preserving all available Lincoln data was given to the members of the Washington County Historical Society at the regular monthly meeting of the organization at the Court House on last Tuesday night. The meeting was well attended by members and friends.

Col. Lucien Beckner, Louisville, head of the Lincoln Research Work in Kentucky, was the principle speaker at the meeting. One of his assistants, Dr. I. N. Reed, who is to carry on the research work here during the next few weeks, was also presented to the assembly. Both Col. Beckner and Dr. Reed expressed their admiration for the interest and work that Washington Countians are manifesting and doing in the way of putting the county on the map.

Col. Beckner spoke of the numerous outstanding public men who have come from our county, mentioning in particular Felix Grundy, Gen. Matt Walton, W. C. McChord, and Prof. George W. Colvin.

The society voted to observe the 125th anniversary of the birth of Abraham Lincoln on Monday, February 12th, with a banquet and a historical program. The president was authorized to name the necessary committees and his appointments are as follows:

Place and menu: Mrs. J. F. Pettus, Mrs. C. F. Bosley, Mrs. Dewey Kimbel. Reservations: Naomi Rodgers, Mrs. T. Scott Mayes, Emma Nunan; Historical Pageant: Mrs. H. B. Gregory, Mrs. Frances Shultz, Mrs. Trolly Young; Speaker: Joe Polin, Rev. Dewey Kimbel.

A report of the progress of the work at the Lincoln Homestead Park site was made by the president, the Rev. Orval Baylor. He said that the log house is completed and ready for the furnishings. Work on the pavilion is now under way and every effort will be made to complete the park in time for dedication during the early spring. It is probable that if the pavilion is ready before the 12th of February the anniversary banquet will be held at the park. Recent visitors to the park site have commented favorably on the work already done and each day's work adds to the attractiveness of the site.

## DEBATE FEATURE ON PROGRAM FOR HISTORICAL MEET

Members of Society Will Serve As  
Judges; Report of Progress On  
Lincoln Homestead Park  
Will Be Made.

### PILGRIMAGE IS PLANNED

The March meeting of the Washington County Historical Society will be held in the Court House on next Tuesday evening, it was announced today. The meeting will begin at 7:30 o'clock. After the business session a debate, Resolved: "That the War for American Independence was of more importance than the War Between the States," will enliven the proceedings. The Rev. Dewey Kimbel and Marshall Duncan will be the speakers for the affirmative and Joseph Polin and "Pat" Grigsby will speak for the negative. Each speaker will be allotted five minutes. A jury of 12 members of the society will be selected to decide the question.

The Rev. Orval Baylor, president of the society will present a detailed report of the progress of the work at Lincoln Homestead Park. Work at the park that has been underway since November of last year, has been slowed down due to the lay-off of men by the C.W.A. but it is hoped that the project may continue until it has reached a point where it can be dedicated and formally opened. Mr. Baylor on Tuesday directed an appeal to Thornton Wilcox, administrator of C.W.A. in Kentucky, to that end. Recently an application for additional material to cost approximately \$600, was approved by Mr. Wilcox. Mr. Baylor's appeal on Tuesday was that

the present crew of workmen be permitted to continue until the park is ready for dedication about the first of May. Mr. Wilcox has taken the appeal under advisement and it is expected that an answer will be forthcoming soon.

Highly elated over the success of the Lincoln Birthday Dinner on February 12th, officials of the society are planning for a number of similar celebrations during the coming spring and summer. At the April meeting of the society, which will probably be held in the auditorium of the high school, a playlet, "Lincoln in the White House," will feature the program. On June 12th, at the Fr. Berry house near Beechland, a playlet depicting the wedding of Thomas Lincoln and Nancy Hanks will be another feature of this year's activities.

Word has just reached the office of the society that plans are now under way to inaugurate, during the year of the 125th anniversary of President Lincoln's birth, an annual pilgrimage to Lincoln shrines, the first one to be conducted this year, starting from Lexington, home of Mary Todd. The announcement is that the tour would begin at Lexington on June 12, the day on which Thomas Lincoln and Nancy Hanks were married. In view of the fact that the local historical society is to hold a celebration on that day, Lincoln National Life Foundation sponsors for the tour, will be expected to make the start at Lexington or two days earlier in order that visitors may reach Washington County in time to participate in the celebration here. Several hundred persons are expected to join in the tour, which will be under the personal direction of Dr. Louis A. Warren, a well-known historian and lecturer.

While no plans for the dedication of the park can as yet be given, it is probable that Senator Alben W. Berry, Senator M. M. Logan and Sen. F. Ryan Duffy will be asked to attend and deliver the principle address.
